PARENT RESPONSIBILITIES

- Ensure your son attends each game or practice on time.
- Notify the coach well in advance of any scheduling conflicts which would prevent your son from attending a practice or a game.
- Be responsible for the loss of or damage to any uniform or equipment while in your son's possession.
- Get involved and assist with your son's team fundraising activities.

PARENT CODE OF CONDUCT

- Remember that you are a role model for your son. He will act like you act. You are also representing EAA/TR Fighting Elk Baseball and the town of Elkhorn, NE.
- Support your son's efforts as a player, as well as the efforts of others. Be positive and encouraging. Do not make negative comments about any player. Remember, they are kids and they will make mistakes.
- Do not use profanity or any abusive action or language toward officials, coaches, players, or other fans.
- If you are not the head coach or assistant, please do not coach your son during practice or games. Let the Coaches' coach and respect their decisions.
- Do not teach your son in a way that contradicts the coach. His failure to perform the way the Coach is teaching may result in limited playing time. Don't force him to make a decision between you and the coach.
- Remain in the stands if attending practice. Parents will not be allowed on the field or in the hitting cages.
- Parents will not be allowed in or near the dugout before, during, or after games. Please ensure your child has all equipment, including Gatorade or water prior to the game.
- Do not confront a coach before, during, or after a game or practice. Do not confront a coach at his place of work.
- Follow the chain of command when there is a concern. Players talk to coaches, parents talk to EAA/TR Fighting Elk representatives, parents make an appointment to talk with the Coach, and then the parents meet with the Head Coach and EAA Representative.
- If there is a concern, you may call and set up an appointment to talk with the coach in person. These subjects will not be discussed during the conference: playing time, team strategy, coaching decisions, technique, other players, or alleged favoritism.
- Do not engage in gossip or negative conversations with others that would bring disruption to the team.

I have read and agree to abide by the parent code of conduct above.

I also understand the consequences for my son if I violate them.

Failure to comply with any of these rules may result in the dismissal of your son from the program.
