ADDITIONAL INFORMATION:

Regular Members are the members of El Cajon National Little League (ECNLL) who have applied for, and been elected to serve as, regular members. Regular members are voting members. The terms are used interchangeably. Regular members include current board members, umpire and appointed managers whom are in good standing (paid dues).

Board Members are nominated from the player membership and elected by the regular members annually. The officers of the board are then elected by the board members. After the election, the Board of Directors shall assume the performance of its duties on August 1st or the end of the All-Star Season, whichever is later. The Board's term of office shall continue until its successors are elected and qualified at the next annual meeting.

Any adult volunteer who is sincerely interested in furthering the objectives of ECNLL may become a Regular (Voting) Member upon payment of dues. As per Little League International recommendation, ECNLL has established a clear definition of regular members in its Constitution. The regular members attend the annual membership meeting which is held within the last month of the regular season. The agenda of the annual membership meeting will include information about the condition of the league, financial information, review of the constitution, and the election of board members for the next season.

If you are interested in helping to ensure that ECNLL continues to provide a quality service to the youth of our community, we encourage you to make the commitment of becoming a regular (voting) member of ECNLL.

Board of Directors:

Any member who is committed to continuing the mission of ECNLL may be nominated (by self or other member) to be considered for the board elections.

Elected board members (Board of Directors) are the stewards of our league and are responsible for the day-to-day operations of the league, from preparing registration to running tryouts and drafts, ordering uniforms, scheduling games and umpires, and much more. After being elected to the Board of Directors, these board members will meet and elect the Officers of the Board.
