Jeff Smith motions to approve meeting minutes from 09/08/2025, seconded by Mike Aanerud, approved unanimously.

**-Snack Bar Report:** The first 3 weeks of fall ball we have \$477.64 in supplies, \$1130.83 in sales, yielding \$653.19 in profit.

**-Financial Report:** Started the year at \$68000, ended at \$15000, meaning we spent about \$52000. Chris reviewed the specifics of spending on our profit and loss comparison sheet. Chris plans to review spending every 30 days.

**-Spring Registration:** After Covid we dropped rates to compensate for the loss of baseball during Covid and we have not raised it since then. New registration rates will be: Foal and Shetland early bird registration \$125, regular registration \$175, late registration \$200. Pinto through Pony is early bird registration \$150, regular registration \$200 and late registration \$250. John proposed an idea of having heavier practice early in the year, then fewer practices with more games as the season progresses. Dates:
