### **Minutes:**

The February Board Meeting Minutes were handed out to everyone present and Brittany Finch motioned to approve them. Andrew Reynoso seconded the motion and they were approved by all present.

### **Old Business:**

- o January meeting notes
- Treasurer Report We are off to a great start, we still need to pay for Uniforms, Porta Potty at Trinity (need locks for all porta potties).
- Player Agent Updates Evaluations went smooth, drafts went smooth. Usual issues, 438 registered (still have room in Bronco, some room in Shetland). Website registration will be useful for creating schedules, updating coach's info, scheduling info.
- Website Coordinator Updates gave Coaches until Wednesday to update info, now everyone has received team info and team sites. Reminders will be sent out to parents. Field information, team scores can be updated. John Rede suggested another Coach's meeting to discuss the website and its usefulness. John and Gene will be working on the game schedules tomorrow. They will be available for review tomorrow night. Terry O'Farrell mentioned a parent is inquiring about picture day schedule. Cheri Powell mentioned that she and other parents did not appreciate personal information being sent to the entire team. This will be changed for next season. The calendar is cut off on the website. The Dicks app will be published on the website to make it easier to see.
- Sports Council Update Same as last month. They were supposed to go to Sacramento to talk about purchasing the old State Youth Facility. The school district has interest and has priority over the YSC. North River Road will break ground in April. The rain has delayed Slant Field. Casino Night tickets will be handed out at the Team Manager meeting. Every team will be required to sell at least one ticket. Volunteers will be needed for set-up/clean-up. - Apparel Updates \$1800 profit for Announcement day. Opening day gifts for Coaches and All-Stars. Football Board liked hats and asked Kristen and Dana to help with their apparel.
- Equipment Updates All equipment went out. No issues, except one Shetland team.
   Additional gear is available. 1<sup>st</sup> Aid bags are available for Coaches.
- O Snack Bar Updates Tenesha made a list of items and prices for approval. Brittany mentioned the "Player Package" option for \$2 a ticket for the Foal and Shetland Division. This will be mentioned at the Team Manager Meeting. Snack Bar cards will be available for credit card purchase at Opening Day at the Apparel Booth. The nacho cheese machine has never been an issue leaving it on at all times (24/7). John Lowry rents the snow cone machine and Leadership students need the volunteer hours. Gene will upload the menu on the website.
- o Events Coordinator Updates Announcement Day went well.
- Fundraising Coordinator Updates Going well, calendars are out. Amanda Reynoso will
  get with Brittany for the prizes. Families are not required to sell all 4 calendars. Magoo
  asked for prices for the Giants tickets.
- O Sponsorship no update, there was a box of the cups from last year's sponsorship. Russell Askew will get back on \$2500 for returning sponsorship and \$3000 for new sponsorship. Stout's scoreboard sponsorship was good for 3 years. Cheri will check with Suzanne for any past sponsors' contracts. West Landscaping's banner is hung and he maintains the fields twice a week in return. Returning sponsors will receive a \$50 dollar discount.

# **New Business:**

o Background Checks – Gene updated that Dicks will be getting out the information. \$10 will cover the background check and the badge. Everyone is in agreement. Opening Day will start at 9 am and will be about an hour. The first game will be at 11am. There will be a 50/50 raffle. The Elks will be running the BBQ. The league will pay for the food. We need a National Anthem singer. Magoo will check with the High School. Darin suggested Callie Twissleman. Lenor Costa was also suggested. It was suggested the prior board pitch the opening pitch to the new board. Derek Stroud was suggested to throw out first pitch. The Riso Boys were suggested to throw the first pitch. Apparel table will be set-up.
