### **New Business:**

- 501C3
  - We were set up as a 501C3 but we had time to put in papers, but we did not put anything through in order to get it done.
  - In order to get tax exempt status we would have to become a new legal entity.
  - Kids Non Profit will help you file the paperwork and get everything done. Cost is around \$1500-\$2000 dollars to get it done. \$75 expedition fee, this will allow us to get bigger donations.
  - Kids Non Profit is the suggested route because they will help write the bylaws and filet he paperwork
  - Tim C Motion to re-name the club for tax exempt status for approximately 2K. Jim Eimiller seconded. Unanimous board vote yes. Motion is passed. Beaver Area Teeball Softball Baseball Association. 8:40
  - Suggested Beaver Softball Baseball Club.
  - Would need to dissolve the old name so no one can use it.
  - Would not be building a new facebook page to support the new name, would update the existing page.
- Tee Ball
  - Lou Diddio moves to put in his resignation. Jim Eimiller seconded, unanimous board vote to accept. Motion is passed. 8:44
  - Cody Boyd with Western Beaver to see about possibly joining our organization for tee ball and for coach pitch. Would give us access to their fields if we needed. Brad will follow up with Cody to get clarity on the issues.
  - Need to appoint a new tee ball commissioner.
    - Brad Cocoran nominates Eric Blinn seconded by Luke Johnson.
    - Justin Parasida seconded by Angela Espey.
    - Board Vote only
    - Board voted in Eric Blinn as the new tee ball commissioner unanimously. 8:53
- Would like to add a board position for Volunteer coordinator.
  - Joe Espey motions to add volunteer coordinator to the board, seconded by Brad Cocoran. Unanimous vote yes. Motions is passed 8:58
  - discussing the volunteer fee and how we would be put in. We have decided to hold off for now due to the administrative overhead.
  - Need to get some outreach to other organizations to see how they do their concession stands so we can better understand how to build the process
  - Want to build the structure, open the concession stands.

- Need to give them other opportunities to be able to volunteer to get their money back.
- Lindsey nominates herself to run the volunteer, Barbie seconded the nomination.
- Sophie Chamberlin nominates herself Amy C seconded.
- Lindsey voted in as the volunteer coordinator by a vote of 5-2. Motion passes.
- Lindsey will be the chair of this committee and Sophie will be the co-chair of this committee as we begin to build this out.

### - The Gator

- Brad has taken the gator to Dave's house to have it worked on.
- Brad researched a new gator and the cost was between 11-15 grand. Not an option
- Dave has taken out the engine to start fixing it. Dave and Brad have volunteered to change the engine on the gator.
- Joe makes a motion to pay no more than \$1500 for the engine and related materials to replace the engine in the gator. Tim seconded. Unanimous agreement from all board members. Motion passes.

## - Bob Dull

- Joe announces plan to re do the field at bob dull for around \$15K. No mound, re do infield outfield etc ... New bases? Many new bases in the secret shed.
- Will it be big enough for 70 ft bases? Joe will be calling to ask.
- No Timeframe
- Also had another bid to fix up the cutler field as well.
- Audience question: Any chance to get updates to the tee ball field? Not as of right now we will take this into consideration in the future.
- Joe calls for vote 9:26 Duraedge to redo bob dull field for \$15. Unanimous yes. Motion passes.
- No meeting scheduled for February. Joe calls for a vote on adding a Feb 11th meeting. Motion passed unanimously by board vote.
- Registration
  - When are we going to open registration? We are behind schedule at this point.
  - Board calls to open registration as soon as we can.
  - Open registration Monday.
  - Baseball registration closes March 2nd as of right now. Should get uniforms back quickly.

- Venezie asked to be included in the conversation around suppliers for uniforms. They had reached out to Eric to ask if they could get involved.
- Could also be an option for spirit wear.
