I agree to abide by the following Facility Rental Rules:

1. No open alcoholic beverages are permitted.
2. No vehicle of any kind is allowed under or near the boathouse except for loading or unloading.
3. Any amplified sound must not interfere with park patrons and surrounding neighbors. Complaints may result in the removal from the facility, pavilion or park, per County noise ordinance 78-110.
4. No pets, except for service animals, are permitted in the park.
5. All trash must be placed inside dumpsters and/or trash receptacles.
6. Electrical outlets and supplies and not to be tampered with for any reason.
7. The applicant is the owner of the stored boat at this facility. The applicant shall indemnify and hold harmless the County and its agents and employees from and against all claims, damages, losses, and expenses, including attorney's fees arising out of or resulting from the use, occupation, management or control of the facilities or any improvements thereon or any furniture, furnishings, equipment and fixtures, which include items stored on site, utilized in connection with the activities performed by the applicant where such claim, damage, loss, or expense is caused, in whole or in part, by the act or omission of the applicant. The applicant shall further agree that he/she will, at his/her own expense, defend any and all actions, suits or proceedings which may be brought against Brevard County in connection with said park and/or facilities arising from said applicant's activities and will satisfy, pay, and discharge any and all judgments that may be entered against Brevard County in any such proceeding.
8. Pursuant to Chapter 119, Florida's Public Records Act, this record is a public document that may be inspected and/or copied.
