**COVID-19 DISCLOSURE, ACKNOWLEDGMENT & WAIVER**

**You agree to not attend any Winter Garden Little League events if exhibiting any of the following new or worsening symptoms of possible COVID-19:**

- Cough
- Shortness of breath or difficulty breathing
- Chills
- Muscle Pain
- Headache
- Sore throat
- Loss of taste or smell
- Diarrhea
- Feeling Feverish or a measured temperature greater than or equal to 100 degrees Fahrenheit
- Known close contact with a person who is lab confirmed to have COVID-19
- Currently living with someone experiencing symptoms of COVID-19

**Temperature certification:**

- I certify that I will take my temperature before arriving at the field and ensure it is less than 100.4° F.

**Duty to Inform:**

- I will inform you if I knowingly come in contact with someone who tested positive within 14 days prior.
- I will inform you and not attend Winter Garden Little League activities for 14 days if I develop any of the above symptoms.
- If I test positive for COVID-19, I will not return to Winter Garden Little League activity without medical clearance.

**Requirements While at WGLL Fields:**

- A mask will be worn at all times. This includes from entering the parking lot until exiting the parking lot, as well as spectator stands, dugouts, and areas adjacent to the fields. Children under 2 years old are exempt.
- Social Distancing of a minimum of 6' is required in all areas. Family/household groups may sit together.
- Please comply with all requests from WGLL designated personnel.

**COVID-19** has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread from person-to-person contact. Federal, state, and local governments and health agencies recommend social distancing and have, in many areas, prohibited group activities.

**Winter Garden Little League** is taking steps to reduce the spread of **COVID-19**; however, **Winter Garden Little League cannot guarantee** that you or your child(ren) will not become infected with **COVID -19**. Further, **attending Winter Garden Little League activity could increase** the risk of contracting **COVID-19**.

By signing this agreement, I acknowledge the contagious nature of **COVID-19** and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by **COVID-19** by attending Winter Garden Little League activity and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by **COVID-19** may result from the act, omission, or negligence of myself and others, including, but not limited to, Winter Garden Little League volunteers, and other participants and their families.

I voluntarily agree to assume the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may incur by reason of Winter Garden Little League activity (" Claims" ). On my behalf, and on behalf of my children, I hereby release and covenant not to sue Winter Garden Little League, its affiliated organizations, employees, volunteers, agents, and representatives, of and from the Claims.
