

**AYSO REFEREE PARTICIPATION CONTEST
OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

1. **SPONSORS:** This promotion (the "Contest") is sponsored by the American Youth Soccer Organization ("AYSO"), 19750 S. Vermont Ave. Suite 200 Torrance, CA 90502, ("Sponsor"), subject to the following terms and conditions. This promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook or Amazon.
2. **ELIGIBILITY:** The Contest is open to legal residents of the United States, and other U.S. territories excluding Puerto Rico. Void where prohibited by law. Entrants must be at least 18 years of age at time of entry and possess a valid form of identification. Entrants must be currently registered AYSO volunteers. Invalid or ineligible entries shall be excluded from consideration. Employees of Sponsor, and Sponsor's subsidiaries, affiliated companies, and agents, and the household members or immediate family members (defined as parent, spouse, child, sibling, or grandparent) of those employees or Referees registered in Section 14 are NOT eligible to enter the Contest. By their submission of entry, participants warrant they are legally entitled and authorized to make such submission, either on their own behalf, or as to information submitted upon the express authorization of another on whose behalf the information is submitted. In the event of a dispute as to the winner's identity, entries will be deemed made by the holder of the email account associated with the entry.
3. **HOW TO ENTER:** During the Entry Period (2/1/16-6/1/16), visit the AYSO National Games website at <http://www.aysonationalgames.org/> (the "Contest Website"), click on the "Volunteer" tab in the tool bar and click on "Referees". Click on "Register Now" and follow the instructions to create an account and register as a National Games Referee. Entrants will be required to fill out and submit the registration form provided. Upon filling out all required form fields, you will be entered into the Contest. Only one (1) entry per person. Entries become the property of the Sponsor and will not be acknowledged or returned.
4. **TIMING:** The Contest begins at 9:00 a.m. PST on February 1, 2016 and continues until 11:59 p.m. PST on June 1, 2016.
5. **PRIZES AND ODDS:** Eighteen (18) weekly winners will receive one (1) complimentary hotel room night at the Official Referee Hotel.

Odds of winning will be determined by the number of eligible entries received. **Prizes are nontransferable and must be accepted as awarded.** Winner will be responsible for all taxes (federal, state, and local) and all expenses not listed herein related to acceptance and use of any prize. Prize will be awarded if properly claimed.

6. **SELECTION OF WINNER:** One (1) winner from entire pool of Referee Registrations will be selected at random each week. Winning is contingent upon compliance with all terms and conditions set forth in these Official Rules; any entry drawn or any potential winner identified thereby found at any time to fail to comply with these Official Rules will be held invalid and ineligible for award.
7. **NOTIFICATION; RESPONSE REQUIREMENTS: WINNER:** Each winner will be notified by phone, U.S. mail and/or email within 5 business days determination of the winner. Eligibility will be verified prior to notification. Within 2 business days of notification, winner must respond to Sponsor. Within 5 business days of notification, winner must complete, execute and return to Sponsors any tax form, affidavit, waiver, release, indemnity agreement, and/or any additional documents required by Sponsor in Sponsor's sole discretion. Failure to comply with the requirements of this paragraph (or the return of any prize or prize notification as non-deliverable) may result in disqualification and in the forfeiture
