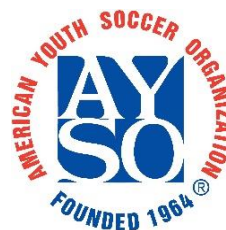
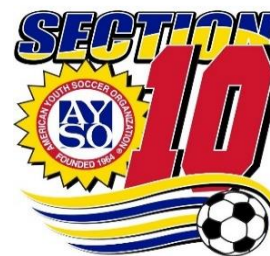

1. Frank Gallucci called the meeting to order at 7:04 pm
2. Morgan Saffari took roll call.
3. Treasurer Report and Budget Discussion – Jorge Tapia: (see attached reports) The actuals are off by \$26,000 due to outstanding invoices. ADs have been notified. Frank suggested not having shirts for League and All Stars next year. Would save \$30,000. All were in agreement. Steve Singer asked if fees could be adjusted if we wanted to bring back shirts. Frank said we could raise fees next year or dip into the reserves. Rocky Kovar said raising fees is a burden for smaller regions. Rocky asked if line item 4021 included the three Section tournaments and Section 10 Cup. Frank said it did. The Epic tournament and 2026 Western States Games were not included. Frank said he was talking to Sections 1 and 11 about divvying up the Tri-Section EXPO account. It would be about \$20,000 for each Section and we could use that towards WSG. Frank asked Jorge to revise the budget and resend to everyone. Dave Howells clarified those changes would be no shirts, no team fee increases and Section 10 hosting 5 tournaments instead of 3.

#### 4. Area Director Reports

Area A – Adrianna Tijerina: Regions are getting ready for Fall and Super Camps. Numbers are low so she is asking them what she can do to help.

Area D – Tonya Clark: Registration is open. Area meeting is next week. All regions are positive their numbers will be the same or higher than last year.

Area E – Debby Tapia: Registrations are finishing, and regions are searching for coaches and referees. Trainings are happening Area wide. Intermediate coach class is on August 9. Numbers are slightly down in 16/19 but not as bad as last month.

Area O – Susan Pinheiro: Same as everyone else. Visalia and Tulare are slightly down. Coach and referee courses are scheduled. Cutler has not submitted their budget and does not have registration open yet.

Area Q – Tammy Slocum: No report

Area S – Robert Benavidez: Numbers are down, especially in 16/19. Will reach out to Area V for Fall. Regions are recruiting coaches and referees. One region is dealing with field issues as they did not get the permit for one of the middle schools they use. They are looking into why it was turned down and other options.

Area V – Steve Singer: Registration is open. Trainings are set for coaches and referees. There were 2 RC elections – Region 58 reupped and Region 254 has a new RC. Everyone is getting ready for National Games next week.

Area W – Dave Howells: About 8,000 players are registered. Some regions are up and some are down. They tend to get a lot of last-minute registrations. There was no July meeting, so no update on 16/19s. Four of the 9 regions have completed all their reconciliations in QuickBooks. Deferred registration fees (5210) - reminded the regions about doing journal entries for this fiscal year. Coach and referee trainings are coming up. Intermediate Referee course will be held in September.

5. Coach Report – Mark Savel: No report
6. Referee Report – Linda Kovar for Chris Doucette: Late in getting training materials released. Advanced Referee is being reviewed and should be out next week. Will send emails to RRAs. Regional Referee is updated. Intermediate Referee is not in review yet.  
Rocky asked if there were any significant law changes. Linda said there were, and they are working on updating the training material. National Referee will be released next week as well.  
Linda said they are hoping to get Intermediate Referee Instructor Evaluator finalized this week. She said Intermediate Referee Instructors will be able to take Intermediate Referee Instructor Evaluator. The criteria will be listed in the course.
7. Management report – Alex Diaz: Would like to encourage Areas to reach out for any training needs/support.
8. Auditor Report – Denise Howells: The office is asking everyone once everything is closed to let them know. It's a hard close – once they know it's done, no changes can be made (but you can still add attachments). Shelley is reviewing everything so if she sees anything she'll notify you. There cannot be any reconciliation discrepancies.

QuickBooks and Divvy will be reviewed soon. There are still regions who have not reconciled since 2024. Everything needs to be done no later than July 30.

9. EPIC Report – Nancy Hernandez: The planning committee had its first meeting June 30. There are 12 members. The next meeting will be July 28. We have received a \$1,000 donation, so most things are going to have to be donated. Focusing on reaching out to the ADs, just waiting on Frank's approval for the letter. Medals will be about \$1,000. We'll skip shirts if there isn't money for them. Looking for in-kind donations. Registration will be open at the end of August. Already contacted Score but hasn't heard back. Will reach out to Augusta. Frank said since we've pulled the money for League and All Star shirts, we could put some of that money towards EPIC. He suggested \$10,000. Steve suggested \$8,000-\$10,000 but wants to see how many donations we get. Susan said a minimum of \$5,000 and then chip in more if needed. Tonya asked if grants have been looked into. Nancy said not yet but will look into it.

#### 10. 2025-2026 Section 10 Playoff Guidelines

Frank made a motion to approve the 2025-2026 Section 10 Playoff Guidelines dated July 9, 2025. Steve seconded the motion. Motion approved.

#### 11. 2025-2026 Section 10 Guidelines

Frank made a motion to approve the 2025-2026 Section 10 Guidelines dated July 9, 2025. Steve seconded the motion. Motion approved.

#### 12. Section 10 Cup

Frank will email the P&L after the meeting, but screenshared on Zoom. \$27,000 in expenses, \$24,000 in referee refunds. Gross profit = \$4,536.31. Factors were low team counts and excess inventory (medals, pins, coins), which will help offset costs for next year's tournament. S10 Cup hasn't been run since 2018.

#### 13. SD Report and info from NBOD

##### a. Region Merchant IDs

Section 10 will be part of the October transfer unless you signed up for an earlier date. Hopefully this will lessen chargebacks. Denise asked if they should use Stack Pay instead of Square. Frank said it is preferred but Square is allowed. Everyone must be transferred by the end of the year.

##### b. Western States Games 2026 will be held in Moorpark. Hotel arrangements have

been made with Courtyard in Simi Valley. Tournament dates are March 14-15, 2026.

c. EXPOs – they are meeting with CVENT for registration and class tracking. It's the same system used at NAGM. It is targeted for next year.

d. AYSO Play is running camps. National would prefer regions use AYSO Play instead of UKI or Challenger.

e. Waitlists are high nationally, so they are looking to see why.

f. Adidas is the new uniform sponsor for United. They will start January 1, 2026.

g. Region and Area boards need to be up to date. Liaisons from National have been reaching out. About 50% of the calls are returned and 50% of the emails are returned. Make sure everyone is responding to the call or email to at least acknowledge it.

h. MOJO is ready to go for the new season. All lesson plans are in it. New graphics have been added. Really encourage coaches to use it.

i. United has 34 new locations this season. There are 6 teams in Dallas.

#### j. AED Update

Doug and the NBOD have been working hard with the lobbyist. They went to the author of the bill and asked for adjustments to be made. He is willing to work on some changes. CalNorth went and demanded the bill be shut down, but the answer was no. AEDs are expected to be on-site in 2028. Online training was approved and will need to start in 2027. Must be renewed every 2 years. They are looking into getting it linked in AYSOU. Dave asked if the training is going to be mandatory for all. Frank said right now it's just coaches. Rocky said Doug said it takes about 40 minutes online to complete and will be CPR and AED. Robert asked if high school coaches, who are already required to have this training every 2 years, can upload their cert. Frank said he would ask. Rocky and Dave agree. Dave suggested that people who take it for work should be able to upload their cert as well.

#### k. Roster Sizes

This doesn't really affect our Section. It was brought up to reduce waitlists. Caps will be changed on roster sizes. Maximum numbers allowed will be double the number

of players on the field. 14/16/19 will be 22, 12U will be 18 and 10U will be 14. The minimum number of players on a roster will be 1 less than the number of players on the field. 14/16/19 will be 10, 12U will be 8 and 10U will be 6. All changes will be made in Sports Connect and Affinity and will be effective August 1. Everything will be updated in the yellow book this week.

#### 15. Open Topics

Lewis is working with Area V to get instructors for their referee courses. Both Intermediate Referee and Advanced Referee now have instructors.

Adrianna asked what the cost is going to be for the CPR and AED training. Frank said right now it's \$10. It will be put out to the regions to see if they'll pay for it like they do with the background checks.

Dave said to be aware of emails coming out from Finance. Frank said it is everything we are already doing. An Area Oversight -Financial Oversight webinar is being held July 16 from 4-6.

Frank adjourned the meeting at 8:27 pm.
