1. Frank Gallucci called the meeting to order at 7:04 pm.
2. Morgan Saffari took roll call.
3. EPIC Report – Nancy Hernandez: EPIC Festival is November 16. There are 11 teams and 55 buddies currently registered. Registration will close September 30. Fundraising goal has been met - \$12,300 has been raised/pledged. The goal is to continue fundraising so there is a starting point each year. The first week of October volunteer and referee forms will be available.

4. Area Director Reports

- A. Area A – Adrianna Tijerina: Everyone has started. Trainings are going on. There are a lot of teams in 16/19.
- B. Area D – Tonya Clark: (emailed report) All regions are in play as of this weekend. We have run an Advance coach class and several 10U & 12U throughout the area. Along with referee training. We have had a couple of our upper division teams play on our AV Alta Soccer team fields, which is the level one pro league up in the high desert that we have been working with. They have been huge supporters of our AYSO Area. Our upper division grew in number this season. The regions waitlists were low as well. Always running into coach volunteer issues but all of the regions have done a great job finding help and getting the players on the field.
- C. Area E – Debby Tapia: (emailed report) All is going very well in upper divisions. Great behavior from players and spectators. Regions have absorbed some players from i9 sports that closed. We are still dealing with coaches who become flagged and have to be replaced. But all the teams now have new, certified coaches. My area is still struggling to obtain financial compliance in Divvy and QB. I send monthly updates to my RCs and Treasurers. Which Area is successful and how/what are they doing?
- D. Area O – Susan Pinheiro: Two regions are up and running. Registration between the two is 1,400. Third region never opened registration. Hanford didn't get up and running this year. Trainings are going on. Oliver got approved to be an Intermediate Coach Instructor.
- E. Area Q – Tammy Slocum: No report
- F. Area S – Robert Benavidez: No report

G. Area V – Steve Singer: Everyone has started. Finished Week 5 for the 16/19s. Trainings are going on. Following up with regions to make sure they stay compliant.

H. Area W – Dave Howells: 2,200 registered volunteers. Coach and referee admins have been busy. A third Intermediate Coach Course was held. 50 people attended. 16/19 is in full swing. There are 29 teams. Been getting emails from Paula about volunteers who haven't completed their background checks. Frank said that was a directive from Doug.

Rocky asked if there is an effort being made to bring background checks back to how it was before. Background checks are out of sync with the start of the season. The average volunteer isn't checking to see if they are compliant. Risk status is now 15 months, not 12 months. Frank said there is nothing in talks right now but can ask.

5. Coach Report – Mark Savel: (See attached report) Committee is putting together a code of conduct for all volunteers. It's being reviewed. If any Areas need assistance, reach out to Mark. He is finding that regions are not following the National Coaching Program. 10U is 3 hours, 12U is 5 hours, Intermediate is 9 hours and Advanced is 9 hours. Coaches shouldn't be on the field unless they are age-specific trained. If coaches are not properly trained, they will not be moving on.

Frank said making progress is ok. Regarding the coach course, the coach will not be penalized for an instructor not running the course for the proper amount of time.

Steve asked if there is a matrix with hours for coach courses. Mark said he'll email it to everyone. He also said if instructors are not doing what they should be doing, we shouldn't be inviting them to continue to be instructors.

Jorge said instructors are only allowed to teach what is in the course – nothing more, nothing less. They can't address the referee abuse program because it's not in the training materials. Mark said they can do it after the class.

6. Referee Report – Chris Doucette: (See attached report) Currently working on EXPO. Phil Briggs wrote a new course. Referees will receive EPIC badges and coins at the EPIC Festival.

Rocky Kovar is our newest National Referee Instructor.

7. Treasurer Report – Jorge Tapia: (See attached reports) National deposited \$515.36 into the Section account. All regions are paid up from last year.

8. Management Report – Alex Diaz: No report

9. Auditor Report – Denise Howells: Monthly reviews follow the QB Checklist. There is an AD Checklist so they can check what their regions are doing. All Divvy transactions must have another person review them. One person does the purchase and uploads everything to make the transactions complete. A second person needs to do the review. There are still regions who are not reconciled in QuickBooks and/or Divvy.

Frank reminded everyone that all regions must be financially compliant to participate in Section playoffs. No exceptions. October 15 is the cutoff for 16/19s.

10. AED Update – As of the last NBOD meeting, there is a bill on Newsom's desk with a 2027 start for training and physical AEDs in 2028. Paula is working on a course so it ties into the volunteer portals. The course will need to be taken every 2 years.

11. EXPO – Registration will open October 15. Opening early to get the current coaches and referees. Vendor registration will open at the same time. Section 1 leads have reached out to Chris, Mark and Alex. Moving forward, each Section will be the lead in all disciplines when they are hosting. Registration will be tiered, starting at \$250 until January. Rocky asked what registration platform will be used this year. Frank said the same as last year. They looked into CVENT, but it would cost \$15,000 per EXPO.

12. Section 10 Cup – Moorpark only has 4 fields available on the dates we are looking at. We need to change the date to stay in Moorpark or change the location and keep the same dates. Frank said he needs to see what other regions have planned for their tournaments.

13. NBOD – Everyone was sent The Insider. Matt Winegar is retiring at the end of this year. The National Office has started the process of looking for a new Executive Director. There is a new policy statement regarding police activity at the fields.

14. Open Topics:

Lewis is working on putting together a National Instructor Course in S10 on December 15.

Linda said if anyone has any send offs due to abuse, she needs to be notified.

Frank adjourned the meeting at 8:14 pm.

- 1. AYSO COACH CODE OF CONDUCT:** AT THE REQUEST OF THE NATIONAL BOARD OF DIRECTORS (NBD), A JOINT COMMITTEE—COMPRISING REPRESENTATIVES FROM COACHING, REFEREEING, MANAGEMENT, AND EPIC—WAS CONVENED TO DEVELOP A COMPREHENSIVE CODE OF CONDUCT APPLICABLE TO ALL AYSO VOLUNTEERS, SPECTATORS, PLAYERS, AND AFFILIATED PARTICIPANTS. THE COMMITTEE'S DRAFT HAS BEEN SUBMITTED TO THE NBD AND IS CURRENTLY UNDER REVIEW.

IN THE INTERIM, IT IS EXPECTED THAT ALL ACTIVE COACHES AND ASSISTANT COACHES ASSIGNED TO TEAMS HAVE SIGNED THE CURRENT "COACH/ASSISTANT COACH CODE OF CONDUCT" PRIOR TO THE START OF THE SEASON.
