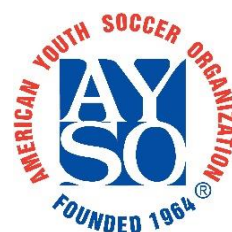

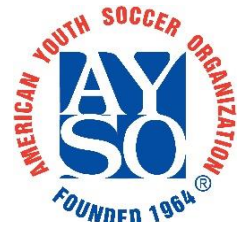

1. Frank Gallucci called the meeting to order at 7:04 pm.

2. Frank Gallucci took roll call.

3. 2025-2026 Section 10 Playoff Guidelines

a. Finish discussion on Hoodies – did ADs poll RCs?

Debby prefers not to restrict them as long as the hoods are tucked in. Susan agreed. Tonya, Robert and Steve said they were fine either way. Denise (for Dave) said no hoodies.

Frank – guidelines will stay the same, with hoods tucked in.

Debby suggested adding no zipper jackets. Any under garment with a zipper is a No.

b. Approve Changes or Order Revisions

Mark suggested bolding text of 14C (sideline participation). Asked if this was the final version of the equitable play rule. Frank said yes, with the changes that were added from last meeting. Pete said except as noted below – make it for approved oversized league rosters. League needs to be added to 3. Mark said teams need to know that Area rules and Section rules differ. Frank will send the changes out for everyone's review.

4. 2025-2026 Section 10 Guidelines

a. Finish discussion on United/Core players

Article 7, 4D – Players may play on a Region core team and a club team concurrently, including United. For the United program, refer to the National website.

Debby said she would defer to the majority as she can see both sides. She is ok with the language.

Tonya said her Area is not really affected by United. She is fine with the verbiage as-is.

Susan agreed with Tonya.

Robert said you can't penalize a United player versus other club players.

Everyone plays. Area S would be devastated and it's an extra headache to police. Steve is ok with the verbiage as long as it's not written somewhere that you can't be in 2 AYSO programs at the same time.

Adrianna said to allow them.

Dave said it was 100% no from his RCs to allow United in Core. He wants to clarify that “Everyone Plays” is everyone plays half a game. Robert said he would change his argument to Open Registration.

Rocky said he’s leaning toward allowing them to play. He is ok with how it is written.

Everyone, except Area W and no response from Tammy, is ok with allowing United to play in Core.

Decision: United can play on Core teams.

b. Discuss other changes to guidelines

Extra is still in the Section 10 guidelines. Steve said with AD approval teams can join Section 1 or Section 11 so leave it in. Debby agrees. Frank said he would adjust the wording to point to the Tri-Section website. Dave said the first sentence is fine and put a link to the website.

Frank said the Section budget will be completed by the end of February. No changes in fees.

Pete said everyone should be aware of emails coming from “Frank” after the meeting agenda has been sent out. For the past several months he’s been getting emails that are not actually from Frank. He said everyone should look at the return address to make sure it is correct.

5. Coach Report – Mark Savel: Not seeing many rosters for coach training.
6. Referee Report – Chris Doucette: We had 15 unaffiliated referees who came out to help at Section 10 Cup. We had 8 instructors at Ken Aston Camp. Attendance was low this year.
7. Treasurer Report – Jorge Tapia: No report.
8. Management Report – Alex Diaz: No report.
9. Auditor Report – Denise Howells: Chelsea is requesting that all Regions set up their individual merchant IDs. It is being done in 3 phases, so please register. Shelley reminds everyone that year-end financials are due July 10, and absolutely no later than the end of July.

She is noticing on audits that Chase does not include cancelled checks. Make sure you are including those if your bank does not automatically include them with the statements. 8 audits are outstanding, 4 are past date, 6 more letters will be going out this week. Only 2 regions have been very responsive to her.

Frank said The Insider went out with the merchant ID information. It will help with what populates on CC statements to help reduce chargebacks. POS purchases will be able to use Stack Pay.

10. EPIC Report – Nancy Hernandez: The EPIC Festival will be November 16 in Camarillo. Region 68 has donated \$1,000. It will be named the Lee Woodward Memorial EPIC Festival. Funds will depend a lot on donations this year since the silent auction at EXPO went to Section 11. She has reached out to Score to sponsor t-shirts. Planning committee meeting will be Monday, June 30 at 7 pm via Zoom.
