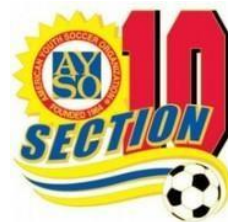

1. Area Director Reports:

1) Regional Administrative

- a. Calendar of events- *This season we will be implementing a more inclusive calendar to share with the regions. This will include regional coach and referee training dates, board meeting dates and other important regional dates that should be shared.*
 - b. Budgets- *Section 10 and Area 10/W will not be raising fees for the MY202-27 season. Region budgets must be completed before registration opens, uploaded to QB Shared documents and forwarded to the Area Director for review.*
 - c. Regional Policies and Protocols Addendums- *Due May 1. Please be sure to add R.A.P. to your addendums.*

- 2) AYSO Updates and Information
- a. PlayMetrics Pilot- *This will be the new registration software program for AYSO. We have three regions beta testing the system for MY2026-27. R148, R242 and R304. Sports Connect will sunset after MY2026 and everyone will need to switch over to PlayMetrics. Regions will also be required to create a new website when the new system becomes active.*
 - b. NED- *A new NED has been hired. Jenni Luke. She started January 22nd.*
 - c. AEDs 2027- *Section 10 ASD Rocky Kovar has been added to the subcommittee for the new AED regulations coming out in 2027. As news becomes available Rocky will share that information directly with the ADs.*
 - d. School Year Registrations- *Out with Birth Year, in with School Year. Be sure your registration program is up to date with the latest.*
 - e. AYSO United- *With David Thomas and staff quitting AYSO United will sunset at the end of the MY2025 season. Currently the only option for AYSO teams wishing to be in the Club circuit will be Alliance. Section 10 and 1 are in negotiations to see if the Section 10 United hubs can join Alliance in Section 1.*
 - f. EXPO- Pasadena- *The second early bird registration ends February 1st. Save your regions some money and take advantage of the early bird.*
 - g. NAGM- Texas- *Grapevine Texas May 22-25.*
