# Frostburg Rangers – AYSO Region 1090 Board Meeting June 3, 2018

# Agenda

- 1. Welcome & Introductions (Kevin)
- 2. Treasurer's Report (Amy)
  - a. \$12,077.85 in account, upcoming expense: Frostburg Fire Department for registration advertisement on sign.
  - b. Lisa Varndell resigned as Area Director. AYSO will waive the requirement to have the 4th signature on the bank account.
  - c. Budget will be finalized and entered on NAP online.
- 3. Recap of Rules and Field Sizes
  - a. The 6U fields and Schoolyard fields will remain as they currently are,  $30 \times 15$  yards ( $90 \times 45$  feet).
  - b. The 15U (Field 7) will remain as it currently is, 100 x 50 yards (300 x 150 feet).
  - c. To better align ourselves with the AYSO National Rules & Regulations, we plan to to go with smaller fields for 8U, 10U and 12U:
    - i. For 8U, 35 x 25 yards (105 x 75 feet) is good. Currently 135'x75'.
    - ii. For 10U, we'll go with 65 x 35 yards (195 x 105 feet). Currently 210'x105'.
    - iii. For 12U (Field 3), we'll go with 80 x 50 yards (240 x 150 feet), but we'd like to center the field so we can use smaller goals than what the City has there. Other groups could still use the outer dimensions for a larger field size. Currently 300'x150'.
  - d. Update: Kevin sent an email to the Board on Friday, June 8th to give an update on registration and to ask the Board for comment on the 8U division following up on a suggestion by Dean to change the setup from 4v4 to 5v5. Dean found out that Grantsville (AYSO Region 861) still does 5v5 in 8U, and Kevin checked with Hampshire County YSL (AYSO Region 1117) and they actually do 6v6 with a goalie but are thinking of dropping back to 5v5 and eliminating the goalie this fall. LaVale also does 5v5 with a goalie. Kevin also asked the Board about whether we should change the field size and goal size, or leave them as-is, and whether

we should continue to allow throw-ins, or do kick-ins as the current rules suggest. Kevin indicated an amendment is proposed at the upcoming AYSO National Annual General Meeting (NAGM) to allow throw-ins for 8U. The majority were in favor of leaving the field and goal sizes as-is, and allowing throw-ins.

# 4. Registration and Teams

- a. AYSO Soccer Camps/UK Internal Soccer Camp
  - i. 31 children currently registered: 9 for mini camp, 22 for half day camp, 1 registered for striker clinic.
  - ii. Coach Training for 6U 10U will be held July 28th, 9 am to Noon.
- b. 269 players are currently registered for the fall, plus 3 scholarships to process:
  - i. Playground 22 (1 group)
  - ii. Schoolyard 30 (5 teams?)
  - iii. 6U 31 (5 teams?)
  - iv. 8U 70 (10 teams?)
  - v. 10U 72 (7 teams?)
  - vi. 12U 32 (2 teams?)
  - vii. 15U 15 (1 team?)
- c. Registration ongoing, so number of teams may change slightly.

#### 5. Volunteers

- a. Board agreed that coach can only be the head coach of one team, but could assist with another division. Coaching additional teams would require Board approval.
- b. Kevin Wagner reviewed the volunteer list from the registration events and also the applications from Blue Sombrero in search for potential coaches.
  - i. Playground 2 coaches possible
  - ii. Schoolyard 4 coaches possible
  - iii. 6U 5 volunteered
  - iv. 8U 5 volunteered
  - v. 10U 6 coaches needed (1 confirmed)
  - vi. 12U One confirmed coach, need to find others
  - vii. 15U Assistants have been determined, will ask a parent to coach.
- c. Coach meetings will take place one evening in July. It will consist of 2 meetings (based on division), all coaches must complete volunteer application in Blue Sombrero and complete training to receive equipment.

#### 6. Sponsors
