

**AYSO 359 VIRTUAL MEETING WITH NOR**  
**August 31, 2023**

**Attendance:**

Jasmin LoBasso, Juan Bernal, Nikki Magarrel, Ilene Schechter

**Lights:**

Juan will check to make sure they are on when they are needed with the fields. They might change when the time changes in the fall.

**Modem:**

Juan will check the two modems in the shed and in the snack bar to find out why they are not responding correctly.

**Insurance:**

There is a three (3) page Insurance Ryder and Juan has only two (2) pages. Nikki will look into her records and re-send all the pages to Juan.

**Sonitrol:**

Nikki is having problems with her code on the alarm. She can arm the device in the snack bar but can't disarm. Juan checked and said that her code was active. Nikki's code is **77** and there is a **78** which was assigned to Tony. Juan & Jasmin indicated that Nikki should just go ahead and use the **78** code. She will check at the field.

**Challenges with Club Teams on the fields:**

There have been major changes in the Rangers that are called out to the field. There are now more full time Rangers and Jasmin will make sure that they come around the fields when AYSO is at practice and play to make sure everything is going smoothly. When AYSO is not using the field, it is open to the public and anyone can play there. There are both football and soccer leagues. NOR will try and contact all the teams. We mentioned a few team colors and Juan will communicate with them. Juan will come out to the fields about 4pm when practice is set up to find out if these other leagues are interfering with AYSO. Fields get tore up and then NOR needs to send out maintenance for repairs.

### **Two (2) C-Trains:**

They were broken into even though there were four (4) locks. They were cut and items were emptied out. AYSO lost the golf cart, paint machine, equipment and uniforms. All the locks have been changed and now they can't be cut with a bolt cutter. Nikki is looking to get them off the property permanently.

### **Bathrooms:**

The service comes early in the morning to put in toilet paper into all the stalls. By mid-day they are dirty and without toilet paper. Nikki doesn't mind supplying extra toilet paper but not to clean them. Nikki asked if maybe mid day they can send someone to clean the bathrooms and put the supply of toilet paper into the stalls.

### **Shed:**

The shed will be cleaned out this weekend. The U8 nets were removed and the outlet plug is not working. There is no power. Juan will come over and check it out.

### **Painting the fields:**

AYSO is outsourcing the painting of the fields for soccer season for all the individual fields.

### **The Shelter:**

The shelter is reserved and rented out to the general public but that doesn't mean that they can also set up bounce houses or other equipment on the fields during a soccer day. Jasmin will make sure that the contracts are spelled out.

### **Allstars:**

Nikki wants to use the fields for the Spring. Jasmin indicated that you can now go online to reserve but only within a 180 day start date. She indicated it is better to come in and fill out the papers personally so they can let Nikki know which fields are available. Fields 2 & 3 are available from January - April 2024. Make sure if you need lights that is also specified.

### **Concessions:**

Nikki said that we can't find volunteers to help so AYSO will not open the concession to sell any food. Shelly does the inspections but it is not necessary at this time.
