2026 Apricot Jam Tournament Team Invitation



AYSO Region 363 is proud to invite your team to the Apricot Jam Soccer Tournament

- Scope: AYSO Invitational – open to AYSO teams from all Sections
- When: Saturday & Sunday, April 18th and 19th, 2026 – **Boys and Girls Divisions**
- Where: The tournament will be held at Arroyo Vista Community Park, 4550 Tierra Rejada Road, Moorpark, Ca. 93021. There is no charge for parking. No pets are allowed at fields. No overnight parking.
- Who: AYSO boys and girls teams in age divisions: U-14 (11v11, max 15 players), U-12 (9v9, max 12 players), and U-10 (7v7, max 10 players) divisions. All participants must be registered for AYSO Membership Year 2025.
- What: Each team participates in three pool games: two held on Saturday and one on Sunday morning. The highest-ranking teams proceed to a fourth Playoff/Final round game scheduled for Sunday afternoon. Game durations are as follows: U-14—60 minutes, U-12—50 minutes, and U-10—40 minutes.
- Why: Region 363 is holding the Apricot Jam Soccer Tournament to raise funds for training, fields, equipment, maintenance, and youth scholarships.
- Awards: Each player receives a tournament pin; medal awards go to all players of the 1st through 4th place teams.
- Entry Fee, Refunds: U14 - \$700, U12 - \$650, and U10 - \$600. If the tournament is canceled and not rescheduled, full refunds are provided. Teams that withdraw more than 40 days in advance receive a complete refund; however, no refunds are issued for withdrawals within 40 days unless another paying team takes their place.
- Referee Fee, Refunds: A \$350 deposit, refundable within 30 days following the tournament, will be returned provided that referee assignments are fulfilled by *Eligible Referees*. Each participating team is required to supply a qualified three-person referee team to officiate three matches during the tournament. For further details, please consult the Referee Plan. **Teams bringing a referee team will be given priority placement; teams with no referees are subject to being waitlisted.**
- Rules: A full set of Tournament rules and the Referee plan is posted on the tournament website.
- Acceptance: The deadline to apply is March 18, 2026. Tournament spots fill quickly, so apply early. Complete applications submitted on time receive priority. Teams will be notified of their status within 48 hours after the application deadline. Unaccepted teams may request a returned check or join the waiting list.

 2. Complete the Tournament Application package, including the Tournament Application, Guest Form, Referee Information Form, and the Affinity Tournament Team Roster, in jersey order.

 3. Both the application and team roster require the signature of the Regional Commissioner, while the Referee Information Form must be signed by the Referee Administrator.

Invitational Tournament Rules**
Boys and Girls April 18th & 19th 2026



CATEGORY	RULE
1) JURISDICTION	<p>A. Unless otherwise noted, the current AYSO National Rules and Regulations, Section 10 and FIFA Laws of the game will be used for this tournament. The following rules are intended specifically for this tournament ONLY!</p> <p>B. The Tournament Committee (incl. Tournament Director, Assistant Director(s), Field Director, Referee Director and other designated staff) will have jurisdiction over all games played. Disputes will be resolved by the end of the soccer day. Referee judgment calls are NOT subject to dispute or protest!</p>
2) FEES	<p>A. Entire fee and referee deposit must accompany tournament application and will be returned if application is not accepted. Fee must be a single check issued from the respective Region's account (no personal checks).</p> <p>B. Fees are U-10 \$950 (entry fee \$600, plus referee deposit \$350), U-12 \$1000 (entry fee \$650, plus referee deposit \$350), U-14 \$1050 (entry fee \$700, plus referee deposit \$350).</p>
3) APPLICATION / ACCEPTANCE	<p>A. The deadline to apply is March 18, 2026. Tournament spots fill quickly, so apply early. <u>Complete applications</u> submitted on time receive priority. Teams will be notified by email of their status within 48 hours after the <u>application deadline</u>. Teams accepted will be posted on the tournament website www.moorparkayso.org.</p> <p>B. Unaccepted teams may request a returned check or join the waiting list. We will still take applications after the due date until the pools are filled.</p> <p>C. Team entry applications and all necessary forms are available on the website, www.moorparkayso.org. Only legible, completed, and signed application packages will be accepted.</p> <p>D. The complete Tournament Application package includes the Online Interest Form, Tournament Application, Guest Form, Referee/Youth Information Form, and the Affinity Tournament Team Roster, in <u>jersey order</u>.</p> <p>E. Rosters must be from the eayso/Affinity program. List the eligible players by jersey order with last name, first name, date of birth, and AYSO ID. Include Head Coach and Assistant Coach names and AYSO IDs. The Region Commissioner or assigned Representative must verify and sign the roster.</p> <p>F. Make <u>one Region check per team</u>—covering both Entry and Referee fees</p> <p>G. Make check payable to: AYSO Region 363 Apricot Jam.</p> <p>H. Please mail the completed application package to: Apricot Jam Tournament, c/o Lisa Viescas, 12954 View Mesa St., Moorpark, CA 93021</p> <p>I. The primary form of communication between the Tournament and applying teams will be email and the Tournament website. Teams must designate a Team Contact on their application who has email and Internet access.</p>
4) REFUNDS	<p>A. Teams withdrawing 40 days or more before the tournament will be issued a full refund.</p> <p>B. Teams withdrawing less than 40 days before the start of the tournament will only be issued a refund if a paying replacement team can be found. Failure to meet the Referee requirements can result in forfeiture of referee deposit, see Referee Plan for complete details. If all assignments are completed, the entire referee deposit of \$300 will be refunded within 30 days of the completion of the tournament.</p>

5) RAINOUT/ CANCELLATION	<p>A. If the tournament cannot be held due to weather, or other conditions beyond the control of the hosts, then a full refund will be sent to all teams.</p> <p>B. If only a portion of the first day is rained out, and conditions permit, all teams will be expected to return on the second day to resume the tournament. Any team not able to return will receive a refund only for the scheduled games not played on the first day, and there will be no refund for games not played on the second day.</p> <p>C. If any portion of the second day is cancelled due to weather or other conditions beyond the control of the tournament hosts, then a pro-rated refund will be sent for any scheduled pool play games that were cancelled.</p>
6) PLAYERS/TEAMS	<p>A. To play, all players on participating teams must be properly registered in the current AYSO membership year, Coaches are responsible for ensuring that all players meet eligibility requirements.</p> <p>B. The Official JERSEY ORDER roster, see rules 3D and 3E, must be verified and approved by each player's Regional Commissioner. Roster changes may be submitted (with the written approval of the Regional Commissioner); however, these changes must be received by the Tournament Registrar the Thursday prior to the tournament.</p> <p>C. 3 Guest Players (players from a different region from the applying team's region) will be allowed for each team. However, the Guest Player will be required to have the approval of both the Guest Player's regional commissioner and the Host Team regional commissioner (see Guest Player Form).</p> <p>D. Coed teams will be accepted; however, they must play in the boy's divisions only.</p> <p>E. Division U-14 will play 11-v-11, and there will be a roster limit of 15 players per team. Division U-12 will play 9-v-9, and there will be a roster limit of 12 players per team. Division U-10 will play 7-v-7, and there will be a roster limit of 10 players per team.</p> <p>F. All players must participate in at least half of each game. Teams violating these rules may face protest, forfeiture, or disqualification as determined by the Tournament Director.</p> <p>G. According to region policy, players can move up one division but not down. If a player was asked to play up in the primary season (such as high school players), they should not have to do so again in the secondary season.</p>
7) COACHES	<p>A. Each team is limited to one Head Coach and one Assistant Coach only. These coaches must be the ones listed on the Official JERSEY ORDER team roster.</p> <p>B. Roster must include the names and AYSO ID numbers of both the Head Coach and Assistant Coach. Both must be a MY2025 AYSO registered volunteer, certified at the level they are coaching and have completed Safe Haven within the last two years, CDC Concussion Awareness training.</p> <p>C. It is the Regional Commissioner, or the Region Assigned Representative responsibility, to check and ensure that all Coaches submitted are eligible as stated in rule 7B.</p> <p>D. Coaches are expected to set an example for their team in exhibiting proper AYSO behavior and Kid Zone behavior. Coaches are expected to remain in the technical area during games and only enter the field of play as requested by the referee. The coaching area is defined as one yard from the touchline and not more than ten yards either side of the halfway line.</p>

8) REFEREES

- A. Please see the Referee Plan for complete details.
- B. Each team participating in the Apricot Jam Tournament must provide a **“Qualified” referee team** which consist of **3 experienced “Eligible” Referees**.
- C. **Eligible Referees** must be registered as a volunteer for the 2025 membership year, must have completed the Safe Haven within the las two years and must be AYSO Referee Certified. A **“Qualified” referee team** is expected to have 3 experienced “Eligible” referees. Each 3-member referee team is expected to have at least one comfortable centering in the division of the team they represent.
- D. It is the Regional Referee Administrators responsibility to check and ensure that all Referees submitted are eligible as stated in rule 8C and that they are AYSO Referee certified at the level stated. If we become aware of any Referees not meeting the above requirements, there will be NO reimbursement for the game assigned to or officiated by that referee.
- E. If requirements are not met, the referee deposit will be forfeited. If all assignments are completed, the \$350 deposit will be refunded within 30 days to the Region address listed on the Referee Information Form.
- F. Youth referees will only be allowed if they are not a player in the tournament and must be at least 2 years older than the age group they are refereeing. Care must be taken when considering whether to allow a youth referee to officiate in the heated environment of a competitive tournament. These referees must always have their Youth Volunteer Application form with them and present it to any Tournament official upon request.
- G. Not providing at least one qualified center referee may constitute grounds for forfeiture of your referee deposit.
- H. All referees must be in full Uniform as defined by AYSO and USSF, including the Referee Badge. Referees not in uniform will not be permitted to referee games, and their team's referee deposit will be subject to forfeiture.
- I. Referees are expected to check in at the Referee Station at least 30 minutes prior to their assigned game. Failure to appear on time may result in a replacement referee crew being assigned to the field.
- J. Referees will be expected to uphold the tournament rules, AYSO guidelines and FIFA laws. Any failure of the referee to uphold these rules may be cause for dismissal from the tournament and will place a team's referee deposit refund in jeopardy.
- K. We strongly suggest that coaches with teams playing in the tournament refrain from refereeing.
- L. Any changes to the referees submitted with your application must be submitted no later than 14 days prior to the tournament. Any changes or substitutions to the referee crew requires the submission of a new form signed by your Regional Commissioner or Regional Referee Administrator.
- M. We aim to have the Referee Schedule released by the Monday before the tournament. Changes are inevitable, please contact us as soon as you know there is a change and be mindful that all referee changes will delay the release of the Referee Schedule.

9) FIELDS	<p>A. Location: Arroyo Vista Recreation Center 4550 Tierra Rejada Road, Moorpark, California, 93021.</p> <p>B. All fields will be set up and taken down by the tournament staff.</p> <p>C. Trash cans will be provided at each field. Teams will be expected to clean up all trash in their area before leaving.</p> <p>D. Please observe the following Facility Use Rules while attending the tournament: NO pets, NO BBQ's other than what is provided by the park, NO overnight parking, NO parking signs are strictly enforced.</p> <p>E. Parking is limited but FREE, allows time to walk and/or carpool.</p>												
10) FORMAT	<p>A. This is a pool-play tournament. Each age division will be bracketed into playing pools.</p> <p>B. Where there are sufficient teams, divisions will also be separated into multiple competition flights.</p> <p>C. Each team will play a minimum of 3 preliminary games, usually two held on Saturday and one on Sunday morning within their respective pools. The highest-ranking teams proceed to a fourth Playoff/Final round game scheduled for Sunday afternoon.</p> <p>D. Number of teams advancing per pool will be determined by the number of pools in the division</p>												
11) CHECK-IN	<p>A. Teams must check in at least 60 minutes before their first game with four completed game cards (not provided), listing all players by jersey number and matching the official roster. AYSO Player Registration forms with verified signatures are required; photo IDs are not needed.</p> <p>B. Coach must always have these Player Registration forms with them and ready for presentation to Tournament Officials.</p> <p>C. Late arriving players must be escorted to the check-in station by a team official along with game cards for games not yet played, their Player Registration Form, and be cleared by the Tournament Staff <u>before</u> participating in any games.</p>												
12) FIELD MONITORS	<p>A. There will be a tournament Field Monitor assigned to each field, and will report to the Tournament Field Director.</p> <p>B. Field Monitors will be the first to respond to any incidents or injuries, and will be in contact with the rest of the tournament staff by radio. Tournament participants are encouraged to report any concerns immediately to the Field Monitor, and also to respectfully follow any instructions given by the Field Monitor.</p>												
13) GAMES	<p>A. Pool play games will consist of 20 to 30 minute halves depending on the age division (see chart below) with a five-minute half time. There will be a running clock during the match including substitutions. There will be no time added on for injuries or time wasted in qualifying rounds. Games will expect to end on time, and may be shortened if they started late. Pool play games may end in a tie.</p> <p>B. Championship games will be full length for that division (see chart below). Championship games will be played until there is a winner (see Medal Round rules below).</p> <p>C. The length of each half in the games are as follows:</p> <table><tr><td>Division</td><td>Pool Play</td><td>Final Rounds</td></tr><tr><td>U-10:</td><td>20 minute</td><td>20 minute</td></tr><tr><td>U-12:</td><td>25 minute</td><td>25 minute</td></tr><tr><td>U-14:</td><td>25 minute</td><td>30 minute</td></tr></table> <p>D. The “home” team will be the first team or top team listed on the game schedule and will be responsible for providing the game ball. The home team will be situated on the South or East side of the field, and the visitor will be situated on the North or West side. Spectators must remain on the side of the field designated for their team.</p> <p>E. The home team will change jerseys or don pennies in the event of a color conflict with the visitor team. 	<p>F. There will be no warming up on the field. Teams must warm up prior to taking the field. As soon as the previous game has ended, teams must clear the field and the teams for the next game must take their places.</p> <p>G. FORFEITS: Teams must check in at the designated Tournament Administration Tent 30 minutes prior to the start of the game. There will be a five-minute grace period at the start of the game for a team to take the field before a forfeit is declared. The score for a forfeit match will be 1-0 for the remaining team (See STANDINGS for the points to be awarded). For U-10 division teams, there is a minimum of 5 players on the field to continue a game. For U-12 the minimum number is 6 players. For all other divisions, there must be a minimum of 7 players to continue a game. If a team cannot field the minimum number of players, the game will be abandoned and a forfeit will be declared.</p> <p>H. SUSPENDED GAMES: The Tournament Committee may determine to end matches early if field schedule is behind due to game delays, interference, or if weather conditions provide unsafe conditions; The Tournament Committee will determine the outcome of any single game which is terminated prematurely (due to inclement weather, participant injury, or interference by outside party, etc.).</p> <p>I. ABANDONED GAMES: if any pool play games cannot be played due to circumstances beyond the control of the tournament, the final standings will be determined by the Tournament Director or designee. Note. This does not apply to games which were shortened due to a late start. Only the Tournament Director or designee can declare a game to be abandoned or not played.</p> <p>J. There will be a running clock during all pool play games. There will be no time added on for injuries or time wasted during substitutions. Each coach is urged to have their team ready at the start of each half and to conduct substitutions in as expedient a manner as possible</p>
14) SUBSTITUTIONS	<p>A. Substitutions shall be allowed approximately mid-way through each half for ALL divisions U-10 through U-14 and will be recorded on the game cards by the referee.</p> <p>B. All substitutions must be approved and recognized by the referee. Substitutions may be made for injured players; however, they may not return until the beginning of the next quarter and will be considered as having played the current quarter (exception: an injured player not replaced may return to play at any time with the referee's permission).</p> <p>C. Substitutions in all overtime periods of medal round matches will be at the beginning of the periods only.</p>
15) STANDINGS	<p>A. Standings for pool play games will be determined on the "ten-point system" as follows:</p> <ul style="list-style-type: none"> • WIN = 6 points • TIE = 3 points • LOSS = 0 points • GOAL = 1 point per goal scored up to a max of 3 per game, win or lose • SHUTOUT = 1 point (for an earned shutout, including a 0-0 tie) • FORFEIT = 7 points (scored as a 1-0 win, no shutout points as it is not an "earned" shutout). If a team forfeits a game during pool play, then all games played against that team will be scored as a forfeit. • RED CARD/SEND OFF = 2-point deduction, including player, substitute, coach, and spectators <p>B. Tie Breakers in standings will be determined as follows:</p> <ul style="list-style-type: none"> • Head-to-Head competition • Fewest goals allowed (not including forfeit) • Most wins (not including Forfeit) • Least red cards/send offs • Least yellow cards/misconduct • Most Shutouts (not including forfeit) • Best goal differential, max 5 per game. • Coin toss

	C. At the end of pool play Standings will be updated approximately every hour at the Tournament Scoreboard and on our website. The deadline to challenge the posted results will be at the conclusion of Pool Play.
16) ADVANCEMENTS	<p>A. Pool winners (and in some cases wildcard teams) will advance to medal round play.</p> <p>B. Teams will play semi-final and/or championship final matches, depending on the number of teams in each pool and the format of play for that flight.</p>
17) MEDAL-ROUNDS	A. All medal round matches ending in a tie will have two full overtime periods of five minutes in length with teams changing field direction after the first five-minute period. In these matches, if still tied after overtime play, the game shall be decided by FIFA kicks from the penalty mark.
18) AWARDS	<p>A. Medals will be presented to coaches and players from the first place through the fourth-place teams in each division.</p> <p>B. A tournament pin will be provided for each player and coach.</p> <p>C. Awards will only be handed out provided all Preliminary and all Final games are completed within the teams Bracket.</p>
19) CONDUCT	<p>A. Coaches will be expected to set a positive example for the team and will be held responsible for the actions of their team, including spectators. All spectators must remain behind the control line and between the 18-yard lines. Two coaches maximum per team, and they must remain in the marked coaching area (within ten yards either way from midfield).</p> <p>B. Referees will be required to complete a game misconduct report for all misconduct during the game, as well as any incidents of interference by spectators.</p> <p>C. Any coach or spectator ejected must immediately leave the vicinity of the playing field (out of sight and sound) and will be prohibited from attending the next scheduled game. Any player sent off (red carded) must immediately leave the vicinity of the game (under supervision of their parent or Safe Haven-certified adult), and may not return to the field of play during the current game, including for the post-game handshake, and may not be substituted for, and is suspended from participation in the next game. There will be penalty point deductions for all send-offs. Any violent conduct red card or ejection could result in that player/coach/spectator being barred from the remainder of the tournament.</p> <p>D. If it is determined that an ineligible player has participated in a game, the team will forfeit all games in which that player participated illegally. Furthermore, if it is determined that the coach knowingly played a player illegally, that coach will be barred from further participation in the tournament.</p> <p>E. It is mandatory to play a scheduled game. If it is determined that a coach willfully fails to have his team participate in a scheduled game, the coach will be dismissed from the tournament, and the incident will be reported to the respective Regional Commissioner.</p> <p>F. All conduct problems will be reported to the respective Regional Commissioner. All Serious Incidents will be reported to the respective Regional Commissioner as well as Area, Section and AYSO National Office parties.</p>
20) MEDICAL/FIRST AID	<p>A. There will be a First Aid station at the main tent where participants may receive ice, etc. for minor injuries.</p> <p>B. There will be roving first aid response vehicles to respond to injuries on the field. Field Monitors will communicate via radio to call the first aid staff to the field where first aid is requested.</p> <p>C. If an injury is serious, the first aid staff or Safety Director will have a mobile phone to call 911 for emergency response.</p> <p>D. Directions to the nearest hospital/urgent care center will be available at the First Aid station.</p>

21) UNIFORMS/SAFETY	<p>A. All players must wear the approved AYSO uniform only, and all players on the same team must wear matching uniforms (goalkeeper may have a different jersey when in goal. The goalkeeper's jersey does not need the AYSO logo, as long as the player also has the team jersey with the logo.</p> <p>B. Each player's uniform must be marked with a permanently-affixed unique number that matches the uniform number on the Game Card, and may not exchange numbered jerseys with any other player during the game including the goalkeeper.</p> <p>C. Garments may be worn under the uniform (i.e. long sleeves, etc.) during inclement weather, however the match referee will be the judge of what should be allowed or not.</p> <p>D. Jewelry, hard casts, or hard metal or plastic clips on clothing or hair will not be allowed.</p> <p>E. AYSO will not prohibit the use of knee braces by players in AYSO events and programs; providing that the brace is adequately covered and padded in the judgment of the referee, so as to eliminate the possibility of its causing injury to the other players on the field.</p>
22) PROTESTS	<p>A. Protests will be considered only for the following reasons:</p> <ul style="list-style-type: none"> • An ineligible player has played. • One or more registered player(s), present and in uniform, has not played the required one half of the game (except for illness or injury as recorded on the game card). <p>B. All protests must be presented in writing to the Tournament Director within 1/2 hour of the completion of the game.</p> <p>C. All protests will be heard by a Protest Committee of at least three persons selected by the Tournament Director. In all cases, the members of the Protest Committee will be unrelated to either team involved in the protest.</p> <p>ALL PROTEST DECISIONS ARE FINAL!</p> <p>D. Referee judgment calls are FINAL and are not grounds for/or subject to protest or dispute!</p>
23) RULES INTERPRETATION	<p>The Tournament Director retains the right to interpret and apply the tournament rules to the optimum benefit of all tournament participants.</p>
