- Opening Day Recap

 - o Band post will go out to all “AYSO741” addressing the issue with sitting on the appropriate sideline of the team you are affiliated with. This is to avoid confrontations amongst spectators and allows players to stay with their assigned teams.

- Working on Sherwood Park and Larry Moore Park field striping for practice.
- Working with City and Schools to get maintenance schedule as grass is too high and becoming unsafe to practice.
- There are no goals to loan out for practice as last year none of them got returned.
- Every week a Band post will go out to identify which teams are responsible for field set up and take down.

- The City of Paso Robles was audited, and field use cost was an item addressed. The increased amounts below are equivalent to \$1 per field than what “AYSO741” has budgeted for the 2025 season. These new Tier costs will be factored into the 2026 Season budget.

 - o Tier 3: \$4hr
