- **Permit holder/group must carry a printed copy of the permit on-site at all time.**
- On-going permits must be paid by the 15th of the month, for the following month.
- No alcoholic beverages, drugs, or loud music allowed on park grounds.
- No sub-leasing of the field(s).
- In case of rain, it is the permittee's responsibility to call the facility to see if field is playable. If no one can be reached for verification, permittee should determine playability. Fields should NOT be played on if there is standing water or if water is visible from the turf when foot pressure is applied in the grass.
- All incidents that occur (fights, injuries, etc) on any Recreation and Parks facility MUST be reported to the staff on duty at that location.
- Department of Recreation and Parks reserves the right to cancel or reschedule permits due to unsafe playing conditions or Department recreational needs.
- Permittee is responsible for lining and set-up of permitted fields. Lines may not be within 9 feet of potential hazards. i.e. light poles, bleachers, trees, fencing etc.

POLICY CONCERNING CANCELLATIONS AND CREDITS

- To receive a refund/credit for cancelling, the permittee must notify the Municipal Sports Office at least 2 weeks prior to date(s) being cancelled. A 50% cancellation fee will apply to refunds. A 15% cancellation fee will apply if a credit is requested. Any cancellations within 2 weeks will result in no refund/credit.
- In case of rain, the permittee must call the facility to see if the field is playable. If no one can be reached for verification, permittee should determine playability. Fields SHOULD NOT be played on if there is standing water or if water is visible from the turf when foot pressure is applied in the grass outfield area or soccer field. For rain dates, permittee must notify the Municipal Sports Office within 2 working days of the rain dates to get a full refund/credit.

ASSIGNMENT, SUBLEASE, BANKRUPTCY

Upon acceptance of this permit, PERMITTEE agrees to not underlet or sublet the permitted areas or any portion thereof, nor allow the same to be used or occupied by any other person or organization or for any other use than herein specified, nor will this permit, nor any of the rights or obligations hereunder, be transferred, assigned, or in any manner conveyed without the prior written consent of DEPARTMENT. Neither the Permit nor the rights herein granted will be assignable or transferable by any process or proceedings of insolvency or bankruptcy either voluntary or involuntary, or receivership proceedings.

Violation of aforementioned policy will cause the permittee immediate forfeiture of all permit rights and void all current and future permit obligations. In addition, each policy infraction may subject permittee to additional fees and/or monetary Reimbursements.
