

Gaylord Soccer League Pre & Open Meetings Meeting Minutes for June 8, 2022

Meeting Location: Otsego Resort, 5:00 p.m. (pre-meeting), 6:00p.m. (open parents/coaches meeting), 7:00 p.m. (regular GSL Open Mtg.)

Items Discussed pre Open Meeting:

- 1. Pat C. suggested that board email discussions be kept to a minimum. Tts been too hard to track and stay up to date. We need another way to handle new items and ongoing discussions. Tim M. proposed to use Google Docs in order for it to be "live" and to keep discussion items more organized. (Tim M. to create).
- 2. Pat C. informed the board that the City has requested that GSL not water it's fields for a month (TBD) in order for them to complete work/service further down the line. By GSL watering with the work the City is doing they are concerned about water pressure for nearby residents. Not watering is not an option with the fall season coming up. Pat C. to speak with the City regarding potentially watering at night?
- 3. Topics for the Open meeting tonight with parents/coaches:
 - a. Field restoration/field maintenance
 - b. Registration/Teams; late registration (ongoing issue), fee increase/combining 2 seasons into 1
 - c. Coaches stipend
 - d. Training T-shirts
- 4. Discussed possibility of moving registration in 2023 to Jan+Feb w/ late registration period in May to allow for the most time for parents to register
- 5. MOTION- Made by Chrissy N., supported by Pat C., to allow late registration (for Rec.) this season until uniforms are ordered. Motion passed unanimously by voice vote.

Items Discussed at Open Meeting:

- 1. Numerous parents and coaches present, all board members present.
- 2. Pat C. provided an opening introduction stressing the board's focus moving forward and the importance of having this open forum to get feedback, noting many of the board members are new and would like parent/coach input in order to better the program.
- 3. Pat C. reiterated this is not a venue for argument, but to gain feedback/recommendations and then take it back to discuss as a board, ultimately providing responses to the league.
- 4. Discussion points raised by parents/coaches at the meeting;
 - a. Teams staying together (no splitting by birth year), especially teams that have been together for a while- doesn't make sense, who made this decision, parents/coaches were not aware of this.
 - i. When was the decision made to form teams this way (GSL stated 1 ½-2 years ago), why??
 - b. Cuts v. no cuts- tryouts v. no tryouts
 - i. Age appropriate tryouts (older kids)
 - ii. "A" and "B" teams

- iii. Ability for skilled players to play up but yet remain in age appropriate and safe age ivision
- iv. Option for kids to play one OR both seasons, many kids play multiple sports
- c. Improving/growing the program v. players quitting/moving to other programs
 - i. Many players have already quit/left the program due to how the board has handled the program in the past, more considering leaving with the new rule for forming teams.
 - ii. Recruitment needs to be more of a priority
- d. Access to GSL information/more transparency and communication
- e. More social media presence and better marketing of GSL; parent stated that the recent Facebook post regarding the GSL performance at the Petoskey Tournament was great to see, need more of this.
- f. Fundraising opportunities? More like Little League and Hockey... open houses, sales, etc.?
- g. Need for coaches meetings/coaches to communicate during season
- h. Need for referees, barely any at times
- i. Need for coaches, some teams did not have quality coaching (Rec.)
 - i. Discount for coaching (Rec.)?
 - ii. Qualifications for selecting coaches? GSL stated its tough to get interested so many times its whomever volunteers and passes screening
- j. Some parents having issues registering the last few seasons, emails from the board about not being able to register/teams noted as "Full"?

Items Discussed post Open Meeting/Normal GSL Board Meeting-All Board Members Present:

- 1. Great points by parents/coaches, we will work together to address as many of their concerns as possible.
- 2. MOTION made by Pat C., supported by Tim M. to hold joint team formation meeting with all Travel Coaches, Pat C., Sarah S., and Chuck L., ASAP in order to address many of the parent/coach comments by having coaches provide input on their team formation, and to work to prevent any cuts in order to maintain and grow the program.
- 3. Kristen P. announced her resignation verbally (followed up in writing via email on 6/9/22) due to personal reasons.
- 4. Sara M. will assume the role of Social Media manager (formerly a VP task).

 - a. Travel team rules and FAQs, Select FAQs and Recreation Program Information (travel section) indicate 4 weekends of NMSA games, however this was eliminated in the current NMSA rules. Should be updated on all our docs accordingly. Tim M. informed the board that per NMSA's recent rules update this is no longer a requirement. Rebecca H. stated this is GSL's policy though. Tim M. further noted that it is noted to apply to only rec and Travel, not Select. Rebecca H. dismissed herself early with no further discussion on the matter.
