President's Report: Gallucci

- Insurance Certificates are complete. Will send to tournament team coaches
- PK field lease update:
 - Eagles have requested time to discuss lease and responsibilities at the field. Will discuss with Eagles and ASD.

Clearances: Brown

- 131 clearances are in the system, but new coaches need to get all clearances updated.

Field Maintenance: Shipley

- Duraedge will look at our fields and could propose better dirt and conditioner mixes. They may provide materials to Thomas.
- Will meet with E&E Fence to quote permanent fence at IL and netting behind ML.

- Need to get field cart to Meineke to be serviced.
- Golf Cart needs batteries, Approved up to 6 batteries if all are needed, up to \$3,000 [Jameson/Shipley]
- Clean up day is March 14
