ELECTION INFORMATION

All interested candidates/nominees must **c**omplete the Board Nomination Application located under handouts and return to the President or their appointed designee. PLEASE READ THE POSITION RESPONSIBILITIES BEFORE RUNNING/NOMINATING/ACCEPTING.

Nominations may be made upon receipt of Board Nomination/application with the approval by the nominee of their willingness to serve. Such applications shall be submitted to The President or their appointed designee, not later than 8/15 or at least 2 weeks prior to the Parent's Meeting. The President may determine the date each year.

No nominations may be made from the floor on the date of the Parent's Meeting except for offices for which no one has been nominated in advance.

Once all nominations are complete, you can vote in person at the Annual General Parent's Meeting (TBA) or send your email vote by deadline (TBA) to the President or the appointed designee. To vote you must be a registered Fall member in good standing with CSL. No member with outstanding balances or other delinquencies are considered in good standing. This may be confirmed with the Treasurer AND President. No proxy votes will be taken from the floor at the meeting.

Board application can be found under Handouts menu tab on the CSL website. Please note that at this time no Nomination may be made, accepted or elected for President or Vice-President if the Candidate has not served a minimum of two consecutive years on the CSL Board of Directors.
