DIRECTIONS/PARKING

For GPS or Google Maps: 43 Piggery Road, Augusta, Maine.

From the South: I-95 North to Exit 109, bear right off exit to 202 East. Continue to the rotary and take 2nd exit off circle towards Rt. 201/Rt. 9. Cross Memorial Bridge and take immediate right just after exiting bridge. This will be Rt. 9. Stay in right lane to next intersection of Rt. 17, continue straight through lights. The fields are located 1-mile from Intersection on left, (Piggery Road), which is the 2nd left after Dollar Tree.

From the North: I-95 South to exit 113 toward Augusta/Belfast continue on Rt. 3, take immediate right after Kennebec River bridge onto Rt. 201. Proceed straight through to rotary at which time you take the 3rd exit off circle which is Rt. 9. Stay in right lane through next light / intersection. Fields are located 1 mile from light on left (Piggery Rd) which is 2nd left after Dollar Tree.

Rivelli Field is the first field on the left. Linscott Field is the second field on the left.

For Parking: There are three (3) main parking lots.

As you enter the Piggery Road, on your left is the Bureau of Motor Vehicles (BMV) parking lot that is available for parking. This is next to Rivelli Field. You can also walk from there up to Linscott Field.

The other two (2) parking lots are smaller and will fill up quickly.

As you enter into the Linscott Field driveway there will be a parking lot on your right that may be used. As you pull all the way into Linscott Field, the main parking lot is located along the field. Handicap parking will be available here with easy access to the field.

Parking along the side of the road and field is not allowed.

TOURNAMENT RULES

The 2025 State of Maine 11U All-Star Tournament will be a double-elimination tournament.

Each district will need to bring their banner to the opening ceremony.

Playing rules will be per Little League Baseball Tournament Rules. All rules will be strictly enforced by the tournament committee and umpires.

All players, coaches, and spectators are expected to respect each other, property, tournament officials, and umpires. Any misconduct will result in dismissal from the tournament.

The team manager is responsible for ensuring their team is properly equipped and in proper uniform with little league approved patches. Managers and coaches must wear khaki pants, a collared shirt, and athletic sneakers. The shirt shall be consistent with the color scheme of the team they represent.

All teams will submit their eligibility affidavits to the tournament director prior to the start of the tournament.

Only managers, coaches, and players listed on the official tournament eligibility affidavit are permitted in the dugout or on the playing field.

The tournament committee reserves the right to change game dates and start times due to inclement weather.

The home team will be determined by coin flip 60 minutes prior to the game start time (the team traveling the furthest calls the flip). Each team's line-up must be presented to the game director at the time of the coin flip.

Each team must have their equipment out for inspection by the umpiring group.

Pre-game warmups will start an hour prior to the game time. For the first 20 minutes, the closest district will use the batting cages; the furthest district will be on the field. The next 20 minutes will switch between teams. Pre-game field practice times may be shortened if needed to keep games on schedule.

The equipment inspection and home plate meeting between managers and umpires will take place 15 minutes before the start of the game.

All lineup changes and substitutions must be brought to the officials in the scoring booth, and as a courtesy, to the other team.
