



Authority:

The Amity Township Athletic Club Board of Directors establishes policy and must approve all new members. A pool committee, set up by the Board of Directors, is responsible for the operation and membership of the pool and its related facilities.

Annual Membership Dues:

The Amity AC Pool is a private pool funded primarily through membership dues. Annual dues are reviewed and rates are set each year by the Amity AC Pool Committee and approved by the Amity AC. Board of Directors. The annual membership dues must be paid each year before gate tags will be issued to member(s).

Membership Bonds:

Each new pool membership requires the purchase of a membership bond. New members are required to complete the Membership Bond Payment Agreement form as part of the pool application. This onetime purchase is refundable should the member decide not to renew their membership. The membership bond can be purchased in full with the initial membership application, or it can be purchased with three equal installments over the first three consecutive years. Choosing the installment option will incur an additional non-refundable processing fee.

Request for Bond Refund:

Membership to the pool is terminated by a request in writing to the Pool Membership Secretary requesting to transfer the membership bond back to the Amity AC. Requests are placed on a waiting list and monies are disbursed as funds become available. If a membership is inactive for three (3) consecutive years, and the member fails to request their bond in that time, the member forfeits their right to any membership bond reimbursement.

Gate Tags:

Membership gate tags are issued for each family member and are to be used only by the person named thereon. Use of a gate tag by anyone other than the member named on the tag will result in pool membership being revoked. All non-members are required to purchase a guest pass and must be accompanied by an active member when using the pool facilities.



Membership Types:

Family Membership

A Family Membership includes two (2) parents or guardians, unmarried resident children under 21 years of age, and unmarried resident children 21 years of age and over who are full time students. Full time students may be required to demonstrate proof of current enrollment (transcripts, student ID, etc.).

Associate Family Membership

There are several Associate Family Memberships available. These are options that may be included with a full membership with an additional fee.

1. Unmarried resident children over the age of 21 who are not full time students
2. Other adult (18+) residents of the household who are not immediate family members
3. A grandchild.
4. A full time babysitter who regularly watches the children of the primary member.

Couple Membership

A Couple Membership includes two (2) people, married or unmarried, living at the same address. One member of the couple must be an adult over the age of 21.

Single Membership

A Single Membership includes one (1) adult over the age of 21.

Senior Single Membership

A Senior Single Membership includes one (1) senior over the age of sixty (60).

Senior Couple Membership

A Senior Couple Membership includes two (2) people, married or unmarried, living at the same address. Both members must be an adult over the age of sixty (60).

Student Swimmer Membership

A Student Swimmer Membership is a one (1) year only membership for full time students who are also members of the Amity AC Blue Marlins Swim Team. This membership is only available to those who are not currently members of the pool through one of the other membership types (Family, Single, etc.) The Student Swimmer Membership is only granted if the applicant or parent/guardian sponsor(s) has not been a member of the Amity AC Pool for at least the previous two (2) years.
