II. Approval of the Agenda

IV. Election:

- A. Concessions Coordinator: Three candidates have expressed interest in the two positions available
 - 1. Shelby Michalak initially expressed interest but has not responded back regarding the position.
 - 2. Dan Curley initially expressed interest, but did not send in any bio information to share at the meeting.
 - Kelli Dokey expressed interest, but could not make the meeting tonight, as she had a meeting for the Waltz Fair Board tonight. She did send in a speech to be read at the meeting.
 - a) Due to the lack of information provided by candidates 1 and 2, we will vote for Kellie to fill one of the vacant roles and revisit the other role once more information is obtained from the other candidates.

- b) Vote for Kelli Dokey: 11 yes votes, 0 no votes unanimous
 - (1) Katie to reach out and let all parties know the next steps.
 - (2) Jayd to refund their payments for the program

V. Reports:

A. President:

- Angela Harris is resigning from the board, leaving an opening for a cheer trustee. The open position will be posted for the public to apply. Current board members can also apply if they so choose.
- 2. Camps:
 - Football camp: 82 registrants so far, with a deadline to sign up set for 11:59 pm tomorrow.
 - (1) Football field for camp is no longer available. Katie is waiting to hear back to see if the practice field is available for camp dates.
 - b) Cheer clinic: 9 registrants so far.
- 3. Fliers: Moving forward, any advertisement fliers should also include the logos of our sponsors at the bottom of the page.
- Dick's Sporting Goods coupon: A former parent reached out to see if HJC would be interested in a 20% coupon for a Dicks Sporting Goods for our program participants. The contact has an affiliation with the Toledo store. Katie to see if we can move it from Toledo to Taylor.
- Conditioning: Building use forms for every nearby gym for cheer conditioning and high school football field have been submitted.
- Followup on Jerry to coach -Issue regarding Jerry took place in the 2024 baseball season.
 After following up with Little League Baseball it is not believed to be an issue to allow him to coach for our program, pending the clearing of a background check and the signing of the coaches code of conduct.
- Coaches: An email will go out regarding the need for coaches for the various levels. For football the following are desired:
 - a) two coaches for flag K-1,
 - b) two coaches for Flag 2
 - c) JV is all set
 - d) one coach for varsity
- New Boston Nutrition fundraiser: All board members should sign up for 1 hour of volunteering for the New Boston Nutrition tea fundraiser.

C. VP Football:

- Equipment: Equipment is ordered and should be here by second to last week of July (around camp time)
 - a) Speedflex are in and can be distributed. If you have not done so already, please bring your check to the next board meeting as well as your child's regular helmet.. Jerseys should be here the first week of August. Those will not be passed out until all volunteer checks and physicals are received. We will set a day during practice where parents can come up and verify they have a physical and checks in and pass out jerseys
- Player drafts:
 - a) Varsity is going to be kept the same as done in years past.
 - b) JV and flag will have a draft board with each athlete's name on a notecard and laid out on a draft board so each team can see where each kid is going. Each evaluation sheet is position oriented. Coaches' kids will be evaluated as well. This will be so all players will be seen and open for discussion.
 - c) If there are any issues with draft, for the various levels, final decision will go to:
 - (1) Katie for JV
 - (2) Kenny for Varsity
 - (3) Joe for Flag,
 - d) Flag draft will be held after the first week of conditioning and JV and Varsity will be the second week of conditioning.
 - e) Maximum number of coaches will start at 7 coaches per team.
 - f) All coaches are allowed to attend the draft and discuss picks with one another, but only the head coach can speak during open mic to pick the players.
