



RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT

I, _____, on behalf of my minor child, _____, (“Player”) am voluntarily seeking the services of Fort Wayne Boys Lacrosse and/or 3Rivers Lacrosse as a part of voluntary lacrosse training and instruction. In doing so, I recognize the continuing danger of the pandemic illness commonly known as COVID-19. I understand that it is a respiratory illness and certain precautions, such as covering my mouth and nose and thoroughly washing my hands, have been medically recommended. I also understand that a social distance of six feet be maintained in public spaces has been recommended. As lacrosse is a contact sport, I recognize that such precautions may not be possible, and are likely impossible. By choosing to allow my Player to engage in lacrosse activities, I potentially increase the danger to myself, my Player, and others. Nonetheless, I choose for my Player to engage fully in the training and instruction consistent with the sport of lacrosse. I understand that no special precautions will be in place to prevent the spread of the illness other than self-reporting of illness symptoms by all persons involved and exclusion of any individual deemed to pose an infection risk. Further, I agree that I, and my Player, do not currently have symptoms of COVID-19 and have not had known contact with an infected individual for 14 days. Similarly, Fort Wayne Boys Lacrosse and/or 3Rivers Lacrosse instructors, coaches, and volunteers are not currently ill and have not knowingly been in contact with an infected individual for 14 days.

As such, **I HEREBY VOLUNTARILY RELEASE, HOLD HARMLESS, AND PROMISE NOT TO SUE** Fort Wayne Boys Lacrosse and/or 3Rivers Lacrosse (including its officers, coaches, volunteers, and other associates) should I, or my Player, contract the COVID-19 virus as a result of participation in lacrosse activities **WHETHER CAUSED BY THEIR NEGLIGENCE OR OTHERWISE.**

Further, **I HEREBY AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS Fort Wayne Boys Lacrosse and/or 3Rivers Lacrosse FROM ANY LOSS, LIABILITY, DAMAGE, OR COST THEY MAY INCUR ARISING OUT OF OR RELATED TO MY SEEKING SERVICES FOR MY PLAYER AND BEING ALLOWED ACCESS TO SUCH SERVICES, WHETHER CAUSED BY THEIR NEGLIGENCE OR OTHERWISE.**

I hereby agree this Agreement shall be binding upon and enforceable against me and my Player’s, personal representatives, spouse, assigns, heirs, and next of kin without limitation.

I acknowledge that this Agreement applies to not only myself, but any minors accompanying me (indicated below).

I have read this Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.
