On behalf of myself, my children, my parents, my heirs, assigns, personal representatives I hereby voluntarily release, waive, forever discharge, and agree to indemnify and hold harmless Kenton Little League and the Home Run Memorial Park and each of their respective commissioners, directors, agents, and other employees, its parent, subsidiaries, affiliates, employees, distributors and agents, other batting cage participants, and, if applicable, operator or lessors of premises used to conduct the event/activity, from any and all liability for any and all claims, demands or causes of action which are in any way connected with my participation in this activity or my use of the KLL and HRMP equipment or facilities.
- 4. I hereby certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating in these activities or alternatively I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions, which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.
- 5. I hereby certify that I have read and am familiar with the Batting Cage Rules and Regulations and will comply with the conditions set forth therein.
- 6. I acknowledge and certify that I am under age 18 and I agree I will wear a helmet at all times while in the Batting Cages. I hereby grant KLL and HRMP permission to administer basic First Aid and I authorize KLL & HRMP to contact 911 or other emergency personnel as needed.

By signing this document, I acknowledge that if anyone is hurt, or property damaged during participation in this activity a court of law may find me to have waived my right to maintain a lawsuit against Kenton Little League and the Home Run Memorial Park and each of the other parties listed in Paragraph 3 above on the basis of any claim from which I have released them herein.
