# Berks County Scholastic Wrestling League

By-Laws Established: 6/10/19 Modified and Approved: 10/28/19

## **Article I: Organization**

- 1. Berks County Scholastic Wrestling League (BCSWL) exists for the purpose of developing and supporting viable elementary wrestling programs throughout Berks County, Pennsylvania. The goal of the BCSWL is to develop wrestlers who are capable of meeting the demands required to compete at the highest levels of competition while teaching them the value of fairness and good citizenship. See Appendix 4 for a list of BCSWL Member Teams and the PIAA affiliated schools they represent.
- 2. The BCSWL is a sanctioning body. The sole function of the league is to provide an open forum for Member Teams to organize elementary level competitions under an agreed upon set of by-laws that promote general sameness among competing wrestlers with respect to age, weight category, and skill level while providing a rule of conduct that promotes fairness and good citizenship for all league participants, spectators, coaches, and Member Teams. Member Teams and League Participants who fail to follow league rules and expectations may incur penalties that might limit or prohibit their ability to participate in league events. A current copy of the BCSWL By-Laws will be stored as a publicly available document on <a href="http://www.berkswrestling.com">http://www.berkswrestling.com</a> as a downloadable file in PDF format. No membership fees are assessed. No fines are imposed.
- 3. The BCSWL will be composed of Member Teams from within Berks County with teams being admitted or expelled by a simple majority of votes. Motion to admit or expel can be made by any Member Team representative in attendance at any league meeting.
- 4. The BCSWL is overseen by a Coaches Committee, League Secretary, and a League President. The Coaches Committee will be comprised of one Head Coach and/or team representative from each participating Member Team in the league. Additional committees may be created and/or dissolved by the Coaches Committee as deemed necessary.
  - 4.1. The function of the Coaches Committee is to attend meetings and participate in the ongoing maintenance and development of the BCSWL with the purpose of promoting and developing elementary wrestling and elementary wrestling competitions throughout Berks County, PA that model fairness and good citizenship.

- **4.2.** BCSWL meetings are open meetings where Member Teams may be accompanied by other members of their team staff at meetings but are restricted to only one vote on any BCSWL issue or amendment.
- **4.3.** The League President may choose whenever necessary to host a closed meeting where attendance is restricted to two attendees per Member Team with at least one attendee being a voting representative of that team.
- **4.4.** More than half of the Member Team representatives must be present at a meeting to vote on by-law additions and amendments, new league memberships, or league expulsions.
- 5. The BCSWL will elect a League President bi-annually. Candidates will be elected by a majority vote by the members of the BCSWL Coaches Committee. The responsibility of the league president is to serve the BCSWL for a minimum of one two-year term. League Presidents may choose to be nominated as a candidate for re-election but are limited to serving only two consecutive terms for a maximum of four consecutive years.
  - **5.1.** Nominations for presidential candidates are open to the Berks County wrestling community.
  - **5.2.** Candidates must have attended three consecutive BCSWL meetings prior to the election.
  - **5.3.** Candidates can either be nominated by another member of the Coaches Committee or they can nominate themselves, but potential candidates cannot be selected from the same Member Team as the current sitting president.
- **6.** The responsibilities of the League President include but are not limited to:
  - 6.1. Scheduling the annual pre and post-season meetings and any additional meetings required or requested by the Coaches Committee throughout the year. The annual pre-season meeting should be scheduled no later than October 31st and the annual post-season meeting should be scheduled no later than March 31st. Additional meetings may be scheduled if deemed necessary by the Coaches Committee. The Coaches Committee should be given no less than two weeks notice as to the date, time, and place of a meeting along with a meeting agenda. Clubs are responsible for sharing the agenda with the necessary members of their club to ensure that they are properly representing the thoughts and considerations of their club's coaches and club officers.
  - **6.2.** To lead all meetings from start to finish as efficiently and effectively as possible using Robert's Rules of Order as a guide.
  - **6.3.** To organize and schedule league events and competitions.
  - **6.4.** To communicate and coordinate with outside organizations such as the Berks County Wrestling Officials Association.
  - **6.5.** To create sub-committees as needed from the members of the Coaches Committee.

- **6.6.** To delegate duties and responsibilities that serve to further the cause of the BCSWL.
- **6.7.** To oversee the voting process on issues and decisions requiring resolution. The League President is a non-voting position. In the event of a tie, the president will work with the Coaches Committee to resolve the issue in a non-biased manner in order to arrive at a fair resolution.
- **6.8.** To oversee updates to the BCSWL By-Laws and notify all Member Teams what necessary updates are made when they will be made available to the public.
- 7. The BCSWL will elect a League Secretary bi-annually on the day of the first official meeting of the incoming league president. Electing a League Secretary will be the first official act of the incoming League President. Candidates will be elected by a majority vote by the members of the BCSWL Coaches Committee. The responsibility of the League Secretary is to serve the BCSWL for a minimum of one two-year term with no maximum term limit.
  - **7.1.** Nominations for presidential candidates are open to the BCSWL Coaches Committee.
  - **7.2.** Candidates must have attended three consecutive BCSWL meetings prior to their election.
  - **7.3.** Candidates can either be nominated by another member of the Coaches Committee or they can nominate themselves, but potential candidates cannot be selected from the same Member Team as the current sitting president.
  - **7.4.** The League President may not change or modify the BCSWL By-Laws without approval from the Coaches Committee by majority vote.
- **8.** The responsibilities of the League Secretary include but are not limited to:
  - **8.1.** To take attendance and document any decisions that require further action and any issues that require further discussion.
  - **8.2.** To assist in organizing and scheduling league events and competitions.
  - **8.3.** To assist in communicating and coordinating with outside organizations such as the Berks County Wrestling Officials Association.
  - **8.4.** To assist in the voting processes. The League Secretary is voting position.
  - **8.5.** To update and publish any approved changes to the BCSWL By-Laws as a publicly available document to <a href="http://www.berkswrestling.com">http://www.berkswrestling.com</a> in a downloadable file in PDF format within one week of the agreed upon changes. Member Teams will be notified by email when the updated by-laws have made available to the public.
  - **8.6.** The League Secretary may not change or modify the BCSWL By-Laws without direction from the League President and approval from the Coaches Committee by majority vote.

## **Article II: Eligibility**

- 1. BCSWL Member Teams will represent PIAA affiliated high schools that operate within Berks County, Pennsylvania. It is the responsibility of the Member Team's Head Coach to ensure and be prepared to provide evidence that their Member Team roster is comprised of wrestlers:
  - **1.1.** Currently attending an elementary school that serves a community from the Member Team's PIAA affiliated school. See Appendix 3 for a list of PIAA affiliated high schools in Berks County and the elementary/middle schools that serve them.
  - **1.2.** Attending a private school that is not serving a PIAA affiliated high school, but residing in the Member Team's PIAA affiliated school district.
  - **1.3.** Homeschooling, but residing in the Member Team's PIAA affiliated school district.
  - **1.4.** Currently in grades K-6.
  - **1.5.** No older than the age of 12 as of December 31st of the season in question.
  - **1.6.** Proof of the following should be acquired by the Member Team's Head Coach at registration by obtaining copies of each wrestler's current 1st quarter report card or current school identification card. Parents should be prepared to provide a copy of there wrestler's birth certificate if necessary.
  - 1.7. In the event of a roster challenge the opposing coach is not to make the challenge directly but must contact the league president with a request to challenge on their behalf instead. This directive is meant to avoid any disruption or drama at league events and competitions.
  - **1.8.** In the event of a roster challenge the member team head coach has three days to provide proof of age and/or residence.
  - **1.9.** In the event of a failure to comply or provide the necessary evidence requested, the following consequences will be imposed by the BCSWL:
    - **1.9.1.** First offense of the season noncompliant wrestler(s) must be removed from the roster.
    - **1.9.2.** Second offense of the season noncompliant wrestler(s) must be removed from the roster and the head coach is suspended from the next scheduled league event.
    - **1.9.3.** Third offense of the season noncompliant wrestler(s) must be removed from the roster and the team is suspended from next scheduled league event.
    - **1.9.4.** Continued failure to comply will result in additional consequences that may include long term suspension of the Member Team's Head Coach and/or Member Team expulsion for the remainder of the season.

- **2.** BCSWL Member Teams are required to provide safe environments and safe adult supervision for their team.
  - 2.1. Member Teams are responsible for maintaining current liability insurance policies or follow the outlined liability expectations provided by their home school district. The BCSWL is not responsible for any injuries that occur during Member Team practices or league events.
  - 2.2. Member Teams must follow the required Pennsylvania State Child Clearance guidelines for their respective PIAA affiliated schools as Member Team coaches are considered by the BCSWL to be school and community volunteers. Prospective coaches that would not qualify to volunteer in their respective PIAA affiliated school may not coach for a BCSWL Member Team. Each BCSWL Member Team will be responsible for collecting and reviewing the PA State Child Clearances to determine the appropriate qualifications for all their participating coaches.
  - 2.3. This is a Zero Tolerance Policy. The safety of all BCSWL wrestlers is of primary importance. Clearances must be provided before an individual is permitted to coach. Knowledge that a coach has not provided the necessary documentation or that a coach does not meet the above required clearance to participate as a school or community volunteer should be reported to the League President as soon as possible.
- 3. All participating Member Team coaches and their volunteers are required to follow the BCSWL Coaches Code of Ethics. It is the responsibility of the Member Team's Head Coach to review the code of ethics with their coaches and volunteers. This is a Zero Tolerance Policy. Individuals who fail to follow the league's code of ethics risk suspension and/or expulsion from all league events. See Appendix 1 for a copy of the BCSWL Coaches Code of Ethics.
- 4. All participating parents, guardians, and wrestlers are required to follow the BCSWL Participant Code of Conduct. It is the responsibility of the Member Team's Head Coach to review the code of conduct with their team participants and their respective parents/guardians. This is a Zero Tolerance Policy. Individuals who fail to follow the league's code of ethics risk suspension and/or expulsion from all league events. See Appendix 2 for a copy of the BCSWL Participant Code of Conduct.
- 5. All violations of league rules and codes will be handled on an individual basis in a timely and efficient manner. If necessary, where a Zero Tolerance Policy has not already been mandated, a committee of head coaches will be organized to reconcile a grievance or a violation of league rules and/or behavioral expectations outlined in the Coaches Code of Ethics and/or Participant's Code of Conduct. A resolution will be reached within two weeks of the reported incident. The acting individual(s) in a reported incident may not participate in any league events until a resolution has been reached.

## **Article III: General Requirements**

- 1. Member Team Representatives serving on the Coaches Committee must attend both the Pre and Post-Season Meetings. If the Member Team's Representative is not able to attend a meeting, one team representative may be selected by the Member Team to vote on their behalf.
- 2. Each team must submit a list of available dates for when and where they are able to host league matches. Member Team availability to host lists should be submitted at the Pre-Season Meeting in October.
  - **2.1.** Failure to submit your availability will result in your team not being scheduled.
- 3. Each team must submit an accurate roster to <a href="http://www.berkswrestling.com">http://www.berkswrestling.com</a> by December 31st. Roster information will be used to create the best possible pairings of league participants for league matches. Teams with incorrect or insufficient information, or teams who have not submitted an updated roster for the upcoming season by December 31st will not be permitted to compete in league events and competitions until their rosters are submitted and meet the guidelines listed below:
  - **3.1.** Rosters should be updated weekly to reflect any changes in a wrestler's weight or skill level.
  - **3.2.** A correct roster will be in alphabetical order by last name and include the necessary information for each wrestler. See Appendix 3 for the required roster variables and how they should appear on your roster.

## Article IV: Member Team Rules and Requirements

## In-Season Training

1. While the league encourages organized co-practices and scrimmages between Member Teams that include the respective coaches of each participating Member Team to enhance training, BCSWL Member Team in-season practices may only include eligible team participants from their own PIAA affiliated schools. Member Team in-season practices may not include participants from other teams within Berks County who have opted out of their own respective home programs. See Article II of the BCSWL By-Laws

for Member Team eligibility requirements. See Appendix 4 for a list of PIAA affiliated programs in Berks County.

- 2. Unaffiliated wrestlers seeking training opportunities should be referred to either:
  - **2.1.** there own PIAA affiliated feeder program or,
  - 2.2. a private club that does not function as a PIAA feeder program such as Steel Mat Club.
- 3. Non-compliant teams are subject to consequences as outlined by the BCSWL:
  - 3.1. First Offense Member Team is suspended from BCSWL events until the unaffiliated wrestler is removed from the Member Team's practice room. The Member Team's Head Coach must inform the unaffiliated wrestler that they are no longer permitted to practice with the Member Team in question.
  - **3.2.** Second Offense Policy to be followed as outlined above then Member Team is suspended from the next scheduled BCSWL event from the date of correction.
  - 3.3. Third Offense Policy to be followed as outlined above then Member Team is suspended from the next two scheduled BCSWL events from the date of correction.
  - 3.4. Continued failure to comply will result in additional consequences that include long term suspension and/or expulsion from the league

### **League Matches**

- **1.** League matches must be given priority status. All BCSWL programs must honor league commitments and compete in scheduled events.
- 2. BCSWL matches will take place on Friday evenings in January and February. Matches will begin at 7pm and end by 9pm and will involve up to three BCSWL Member Teams.
- 3. League matches will be assigned by the BCSWL President based on site availability and roster size with the goal of getting each wrestler a minimum of one match with no wrestler wrestling more than four matches in one evening.
- 4. PIAA officials will be scheduled to work BCSWL matches. The BCSWL President will work with the Berks County Wrestling Officials Association (BCWOA) to schedule two paid PIAA officials to work the league matches. A minimum of one PIAA official is required to host a BCSWL match. Additional referees needed will be arranged by the host team. In which case, if an additional PIAA official cannot be obtained then the next qualified adult can be accepted with approval by the guest team(s). A payment structure

- for PIAA officials will be set at the pre-season meeting. Payment for PIAA officials will be equally split between all teams competing in league matches.
- **5.** BCSWL events will follow modified PIAA guidelines. Updates and changes to PIAA rules will be discussed at the BCSWL pre-season meeting.
- **6.** Bout length for league matches is 1-1-1 with OT following PIAA rules.
- 7. Member Teams hosting league events are responsible for providing a designated location within their home district that allows sufficient parking, ample space for competitors and spectators, and use of bathroom facilities.
- 8. Member Teams hosting league events are responsible for obtaining mats with two coach's chairs per mat corner for each team, scorekeepers, timers, number trees, and a medical kit that contains adequate supplies to properly clean up bodily fluids (gloves, clorox wipes, body wipes, nasal tampons, and small plastic garbage bags for waste). An individual(s) from the hosting Member Team should be chosen to be responsible for the med kit.
- **9.** School district security or community police officers are recommended, but not mandatory.
- Only two coaches per mat for each team corner are permitted. Both coaches will be provided with a chair to sit. Parents, spectators, and additional coaches are required to stay off the mats. Additional coaches or parent volunteers are permitted to assist with participants alongside the mats but coaching corners should remain clear. This rule is to be enforced by the home team with assistance from the participating officials.
- 11. All league coaches, wrestlers, families, and spectators are expected to behave in a courteous manner that models the values of good citizenship. See Appendices 1 and 2. The host team and PIAA Officials have the right to have individuals removed from a league event or shut down any BCSWL event that does not follow the league's expectations for appropriate conduct as outlined in Appendices 1 and 2.
- **12.** BCSWL Member Teams and league participants that fail to follow the BCSWL behavioral codes may be subject to suspension or removal from the league pending a review by the Coaches Committee and a vote by majority rule with oversight provided by the BCSWL President.
- 13. Wrestler match-ups will be arranged by the host team using the Member Team rosters to pair two wrestlers of similar weight, age, skill, and experience. Dissimilar pairings should be noted by the host team and left to the discretion of the opposing team's coach when:

- **13.1.** There is a weight difference of more than 5 pounds.
- **13.2.** There is an age difference of more than two years.
- **13.3.** There is a skill level difference of more than two levels.
- **13.4.** There is a competitive experience level difference of more than two years.
- **14.** Coaches with wrestlers that have unique abilities are required to notify the home team's head coach one week prior to the competition. Both coaches should work together to find the best possible pairing for that wrestler.
- **15.** The League Match Rules and Regulations are a Zero Tolerance Policy. Individuals who fail to follow the league's rules and regulations risk suspension and/or expulsion from all league events.

## **Appendices**

## **Appendix 1: Coaches Code of Ethics**

It is the responsibility of the Member Team's Head Coach to make certain that their team is following the rules of the league and that their team participants (participating wrestlers and wrestling families) are fully aware of their own expectations as outlined in Appendix 2. It is also the function of the coach is to properly educate and prepare wrestlers to compete. BCSWL events are designed to develop a wrestler's skills and abilities in carefully conducted competitive environments where the welfare of all BCSWL participating wrestlers will be of utmost importance at all times. In recognition of these concerns, the following guidelines for all Member Team Coaches have been adopted by the Berks County Scholastic Wrestling League.

A COACH must be aware of the tremendous influence, either good or bad, in the education of the wrestler and thus, should never place the value of winning above the value of instilling the highest desirable ideals of character.

A COACH must constantly uphold the honor and dignity of what it means to COACH. In all interpersonal contact with wrestlers, referees, athletic directors, administrators, other athletic associations, the media, and the public a COACH will strive to set an example of the highest ethical and moral conduct.

A COACH will promote the BCSWL program and it's ongoing collaborations with Steel Mat Club and direct their program in concordance with the guidelines set forth in the league's by-laws.

A COACH will be thoroughly acquainted with the contest rules and is responsible for their interpretation to their team members and staff. The rules should be regarded as mutual agreements and therefore will not try to seek an advantage by circumvention of the spirit or letter of the rules.

A COACH will actively use their influence to enhance the attitude of fairness and good citizenship of their spectators by working closely with the booster clubs and administrators.

A COACH will support and show respect towards contest officials and therefore will not include in conduct that will incite players or spectators against the officials. Public criticism of officials, players or other coaches is unethical.

A COACH will meet and exchange friendly greetings before and after each competition with the opposing teams coaches to set a positive tone for the event and demonstrate to their wrestlers that competition is dependent upon mutual respect and cooperation.

## **Appendix 2: Participant Code of Conduct**

In order to ensure the safety and well-being of all BCSWL participants, the league will enforce a Participant Code of Conduct. League Participants will include all participating members of league events and competitions including spectators, parents/guardians, volunteers, and coaches. The BCSWL has agreed to implement a ZERO TOLERANCE policy for all violations of this code. League Participants that violate the code of conduct may be asked to leave the premises of an event pending further action. The BCSWL President and Secretary will then review the incident and determine what disciplinary actions are necessary at that time.

#### **Wrestler's Code of Conduct:**

- **1.** I will treat my parents/guardians, teammates, opponents, coaches, and officials with respect at all times.
- 2. I will demonstrate an attitude of fairness and good citizenship at all times.
- 3. I will always remember to shake the hand of my opponents and their coaches.
- **4.** I will remember that I am representing myself, my family, my team, and the league.
- **5.** I will use positive and appropriate language and will refrain from using curse words.
- **6.** I will not punch, kick, or scream at my opponent, the coaches, or the officials.
- 7. I will listen to my coaches and try my best to follow their instructions.
- **8.** I will work hard and try my best in my training and competitions.
- **9.** I will remember to allow myself to have fun and focus on my own personal improvement while learning to win like a champion and lose with dignity, honor, and respect.

#### Parent/Guardian Code of Conduct:

- 1. I will encourage an attitude of fairness and good citizenship at all times through my actions and words by demonstrating positive support for all wrestlers, parents/guardians, coaches, and officials at all BCSWL events, competitions, and member team practices.
- **2.** I will remember that the matches are for the wrestlers. Win or lose, I will appreciate the efforts of all wrestlers, coaches, and officials and treat them with dignity and respect.
- 3. I will not engage in conduct that compromises the mission of the BCSWL and will refrain from booing, taunting, and/or using obscene language or gestures towards any official, coach, wrestler, or fellow spectator.
- **4.** I will not encourage my child to use illegal moves or dangerous training methods.
- **5.** I understand that the officials have final say.
- **6.** I will respect all coaches and officials and will not engage in any behavior that disrupts BCSWL events or member team practices.
- 7. I understand that I can respectfully request to speak to a coach at a more convenient time.
- **8.** The coach is the only one permitted to address officials with questions and concerns.
- **9.** I will inform the coaching staff immediately if my child has any mental, physical or medical issues that may compromise their well-being or the safety of other wrestlers.

- Experience the number of years a wrestler has actively competed in matches and tournaments (including experience outside of the BCSWL):
  - 0 = zero years of experience (first-year wrestler)
  - 1 = one year of experience (second-year wrestler)
  - 2 = two years of experience (third-year wrestler)
  - 3 = three years of experience (fourth-year wrestler)
  - 4 = four years of experience (fifth-year wrestler)
  - 5 = five years of experience (sixth-year wrestler)

#### • Skill Level:

- 1 = first or second year wrestler with limited ability
- 2 = wrestler competes and places in novice tournaments
- 3 = wrestler competes but does not place in open tournaments
- 4 = wrestler competes and places in open tournaments
- 5 = wrestler competes and wins in open tournaments
