

This Agreement is between GREECE LITTLE LEAGUE, INC., and \_\_\_\_\_ and outlines the Terms and Conditions with the purchase of an advertising banner to be hung at the Greece Little League complex on Latta Rd. in the Town of Greece.

A. \_\_\_\_\_ ("advertiser") agrees to:

- 1) Purchase one (1) 6' long x 3' wide advertising banner to be placed on the outfield fence on Field \_\_\_\_\_. The Term of the Agreement is five (5) full seasons, extending from \_\_\_\_\_ 2026 through September 30, 2030.
- 2) Pay GREECE LITTLE LEAGUE, INC., a total of \$1,425 (one thousand four hundred twenty five dollars) with a first-year payment of \$425 (four hundred twenty five dollars) and subsequent annual payments of \$250 (two hundred fifty dollars). Full remittance is due by April 1<sup>st</sup> of each year during the term of this agreement. A 10% (ten percent) discount (\$1,280 reduced total) is available should the five-year payment be made in full. Should the annual payment not be remitted on time, the banner will not be hung until payment is received.
- 3) Provide GREECE LITTLE LEAGUE, INC. with the appropriate graphics information.

B. GREECE LITTLE LEAGUE, INC. agrees to:

- 1) Provide advertising space at the designated location for a period of 5 (five) years.
- 2) At its cost, provide all first time production and installation costs of the graphics for the advertising banner (*with the cost of any subsequent production, graphics, changes and installation to be the full responsibility of \_\_\_\_\_*).
- 3) Display the banner each year on the outfield fence between April

15<sup>th</sup> and October 15<sup>th</sup>, weather permitting. The banner will be stored and secured during the remainder of the year.

- 4) Provide maintenance and any necessary repairs due to vandalism or damage other than normal wear and tear.
- 5) Remit to *Advertiser* the pro-rated balance paid if, at any time, GREECE LITTLE LEAGUE, INC. is unable to display such advertising for any reason beyond its control.
- 6) Provide \_\_\_\_\_ with the banner upon completion of the Agreement term if requested.
- 7) Provide \_\_\_\_\_ with recognition in the League newsletter, GLL website and at other appropriate locations.

#### C. RENEWAL TERMS

\_\_\_\_\_ ("Advertiser") agrees to:

- 1) Pay GREECE LITTLE LEAGUE an annual fee of \$250 for each of the Next \_\_\_\_\_ years. Terms and Conditions will remain identical to A) and B). A 10% (ten percent) discount is available should either a 3 or 5 year payment (\$675 or \$1125) option be made.
- 2) Should a new banner be requested, terms under A) 2) will apply.
