The regular meeting of the Little League Board of Middletown-Cobb Little League was called to order at 7:30pm on April 23, 2026 by President Geraldine Fagalde

I. Approval of Agenda

The agenda for the regular meeting was distributed. Carmen Xavier made a motion to approve, 2nd by Arryn McCabe and unanimously approved.

II. Review of Previous Minutes

The minutes of the previous meetings on 2/26/26, 3/6/26 & 3/26/26 were distributed. Carmen Xavier made a motion to approve, 2nd by Arryn McCabe and unanimously approved.

III. Consideration of Open Issues

1. Open **Board positions:**

- **Baseball Coach Coordinator:** *No interested persons present.* Paul will continue to cover on an interim basis until if/when we can fill the position.
- **Snack Shack Coordinator:** *No interested persons present or known by Board Members.*
- **Field Maintenance:** *No interested persons present or known by Board Members.*
- **Safety Officer:** *No interested persons present or known by Board Members.* Gerry will continue to cover on an interim basis until if/when we can fill the position.

IV. Consideration of New Business

1. **Tournament of Champions (TOC) Teams:** Discussed current team standings. Gerry advised TOC dates have been set by D2 of May 18th - 27th; end date is set, start date will flex based on number of teams participating. Being that TOC's start May 18th but is based on standings as of May 15th the Board will be asking coaches (at least top 2 of each

division) to reach out to their players/parents regarding availability for TOC dates IF their team ends up first & advise board of commitment by May 1st.

2. **All Star Selections & Brackets:** Discussed selection process for All Stars with ballots being all eligible players by divisions & will be distributed to managers/head coach & all players. Coach ballots to be distributed by May 6th and returned by May 10th (later updated to May 5th - 8th). Player votes will be done in person at practices or games by Player Agent or Board Member. They will vote for up to 12 & NOT vote for themselves. The Board will determine what age brackets we will form teams for after ballots are in. Knowing which players are NOT available for All Stars based on the dates that D2 has released would be very helpful when forming teams (ie other sports starting, summer vacations, etc) as opposed to forming teams based off ages of nominations then finding out players are not available, especially with the short window for confirmations. Teams will be formed on May 12th & uniforms need to be ordered by May 15th. The Board will be asking coaches to reach out to their players/parents regarding availability for All Star dates IF they are selected by May 4th (later updated to May 1st). Carmen Xavier made a motion to approve necessary changes of the bylaws to accommodate the above, 2nd by Arryn McCabe and unanimously approved.
3. **E-Bikes, Scooters, Etc:** Noted Issues with riding/speeding in parking lot, causing dust & tearing up the grass outside the outfield fence. HVLA Board is discussing issues & possible regulations at their meeting tonight. No action taken by MCLL Board but could ask coaches to remind their players to park them once they get to the field, not "hot lap" & NO charging at the field. Previous charging next to the snack shack caused the breaker to trip & refrigerators to lose power.
