### **Waiver of Liability Relating to Coronavirus/COVID-19**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. The exact methods of spread and contraction are unknown. Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death.

**Shore Regional Little League (SRLL) has implemental preventative measures and social distancing protocols to reduce the spread of COVID-19; however, SRLL cannot guarantee that you or your child(ren) will not become infected with COVID-19 while attending/participating SRLL activities. Therefore, if you choose to attend or participate in SRLL activities you may be exposing yourself and your child(ren) to an increased risk of contracting or spreading COVID-19.**

**ASSUMPTION OF RISK:** I have read and understand the above warning concerning COVID-19. I hereby choose to accept the risk of contracting COVID-19 for myself and/or my child(ren) while attending/participating in SRLL activities. These activities are of such a value to me and my child(ren) that I accept the risk of being exposed to, contracting, and/or spreading COVID-19 in order to attend/participate in SRLL activities.

**WAIVER OF LIABILITY:** I hereby forever release, waive and hold harmless SRLL, its Board Members, employees, representatives, agents, officials, managers, coaches, and volunteers of any claim, cause of action, suits, judgments, reckonings, controversies, in law or equity in connection with exposure, infection, and/or spread of COVID-19 relating to attending/participating in SRLL activities. I understand that this waiver means I give up my right to bring any claim including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether know or unknown, foreseen, or unforeseen.

I will not send my child(ren) to a Shore Regional Little League event (games, practices, etc.), and inform our team manager or league official if a response to any of the following would be TRUE.

1. After taking your child's temperature prior to the event, he/she has a temperature of 100.0 degrees or higher.
2. Your child experienced symptoms of COVID-19, including a temperature of 100.0 degrees or higher within 14 days of the event.
3. Your child tested positive through a diagnostic test for COVID-19 within 14 days of the event.
4. Your child has been in close contact, within 14 days of the event with anyone who has tested positive through a diagnostic test for COVID-19 or who has or had symptoms of COVID-19.
5. Your child has been informed to quarantine by their school, or county official, and is currently quarantined.
6. Your child traveled internationally or from a state with widespread community transmission of COVID-19 per the State of New Jersey in the past 14 days.
