2. President's Report

Nick Vivona updates on President's Meeting:

 No major updates at this time – would like to begin discussions on creating committee for tryouts.

Question asked by K. Montagnese: Where will the draft be? Nick Vivona responded by stating tryouts will be at AITE school and the draft will be immediately afterward. AAA draft will be at Italian Center (Judy Vivona will be responsible for making arrangements with the Italian Center - John Tromba/Karen Montagnese will be responsible for making arrangements with AITE.)

Bob Katchko - Field Commissioner:

- Northrop field is completed
- Over the next month he will be getting quotes on a batting cage for Northrop. He will also look into better grade fencing for the bull pen at Vine.

Question asked by J. Tromba – If a batting cage could be part of Northrop improvements? Nick Vivona noted the ground would need to be leveled for that to be a consideration.

- All field winterization is complete.
- A plan is in place by Bob Katchko to install foul poles at Northrop and Vine by the end of January (will need assistance from board and league members).

Brett Szczesny –Treasurer:

- There is \$22,188.62 in the checking account and \$20,983.12 in the CD.
- Will be checking Little League rules to see if there are any concerns with setting up a separate account with a debit card for Snack Bar use only. The intent is to have all snack bar deposits go into the main account and treasurer will move monies to 'Snack Bar' account as needed.
- Suggested discussion for the upcoming season all Snack Bar deposits need to be labelled either Vine or Northrop so they income can be itemized as a line item on the P&L statement.
