- 4. <u>Approval of June 20, 2018 meeting Minutes:</u> Motion to approve the minutes from June 20, 2018. Motion to accept the minutes by Lenny. Antoinette seconds the motion. All board members in favor. Motion passed.
- 5. Financial Report- Jacki and Jordan worked on the budget to address issues to balance the budget.. Debit Card Account has a balance of \$16,682.66. The Money Market Account has a balance of \$299,217.91. No questions on the checks that have been written. The \$35.38 for the St. Tammany Farmer is for the one paragraph posted. Jordan and Jacki worked on the budget from last month. For example: Page 6-moved money to equal with what was spent. Jordan stated that we still have work to do on Keller Field. Under Fields and Parks-Pages 3-4. On Fields and Parks, we had to move \$50,500 in order to be in compliance with

the budget. Took the \$50,500.00 away from Keller Field. We had \$75,500.00 in that line item. The millage amount of 340,000, which was made for current was very conservative. The amount can change to \$345,000. We will get more toward the end of the year. Last year's amount was \$345,207.37. January – June we received \$345,207.37. \$700.00 was moved to Volleyball registration. Budget was updated as of June 20, 2018. All notes are on the side of how and why the money was moved. Budget was approved and accepted. Resolution 18 to amend the 2018 budget.

6. Director's Report: 11-2 on July 28- Back to school bash. St. Tammany Helps blessing box. Going to have two boxes one with the food July 29-9-2. Last week of Swim lessons. Online registration for all activities. We will now have a dance team. Jordan stated that he would like to work on getting the library again for the district. Can be used for afterschool tutoring, computer lab, etc.

Old Business

1. Signage on Community Center Building: Discussion regarding signage on building. All suggested that we not spend money on signage. All also said that it will create more expense. The sign will have LED lights. Jacki stated that we need to show pride in our Recreation District and a lit sign would help. Gerrin makes a motion to add signage for building, Antoinette second- all board members in favor- motion passed

New Business

- 1. Fidelity Bank gave a presentation regarding banking with them.
- 2. Architect did not show up for presentation.
- 3. New sewer treatment system at Keller Field. It was suggested that we check with Pelican Park to see how much they paid for their new bathrooms. Also checking with architects to design bathroom and sewer treatment plant. Jordan was told to not use the field at this time and that if necessary, we can put in some Portalets until we can get the bathroom in use again.
- 4. Adoption of millage Lenny made a motion to keep the same millage rate at 10.82 mils for 2018, Gerrin 2nd. All board members in favor. Resolution 19 to adopt same millage.
