1. Board ultimately decided to reword the addition and hoping the policy committee or a separate committee can put forth a new motion in the future. The motion was tabled.

- 3. Some concerns about allowing outside organizations to use the expensive Hoef-fecker Soccer Field Equipment were raised. The board agreed that they would set quidelines next year.
- 4. D'Orazio put forth a proposal for a renovation project for both Senior Field and LMS Baseball Field. Celtic Roots gave LYA an estimate of about \$21,000 per field. Work will be completed by Labor Day and Celtic Roots will work on one field at a time so at least one of the fields is playable. LYA will contact the school to let them know. D'Orazion motioned to approve. Merritt 2nd the motion. Discussion included timeline on how long this will last, and D'Orazio said it should be done every 10-15 years. Motion was unanimously approved.
