Old Business:

1. **Monies still due to D7 from 2017 Season:** S. Salem - \$200 (All Stars), Sprague - \$125 (All Stars), East Lane - \$150 (All Stars). Cascade and Tri-Cities are paid.
2. **ASAP:** A copy needs to be sent to Cari and LLBB by February 1, 2018 allowing time for corrections by March 13, 2018 date. Currently, LL website is showing that **Parrish, South Salem, and Sprague have plans submitted online.** Please get the plan submitted and registration can be added as soon as registration is completed. Later in season, rosters with manager and 2 coaches can be added to the Data Center. If a league is interested in *hosting a tournament*, the **ASAP MUST be in on time and approved in order to be considered.**
3. **Registration Dates and Times still needed:**
 - a. West Valley: Feb. 1-28 online. In person registration (showing proofs of residency and birth certificates) will be at tryouts on March 17 at Le Creole MS – time TBA
 - b. Sheldon: March 3 from 11 AM – 1 PM and 3 – 5 PM at Sheldon HS indoor practice facility
 - c. S. Valley: February 3 from 10-2, February 17 and 18 from 12-4 At Cottage Grove HS
 - d. S. Salem: Will be held at Judson MS – no dates or times submitted
 - e. Mid Valley: February 17 and 24 believed to be sign ups held at Timber Ridge, March 3 tryouts place unknown.
4. **Financials:** They are due by February 15, 2018. Please contact Cari or D7 staff with any questions.
5. **Charter and Insurance:** This should be submitted on January 1, 2018. Leagues still needed to submit: Cascade, Eugene, Keizer, Mid Valley, Sheldon, South Salem, South Valley, West

Salem. Registrations/tryouts should not be held until charter and insurance are completed. Leagues and League personnel are NOT covered by insurance if it's not paid. Can be completed online at Data Center.

- e. Item 5: Schedules/Tournament eligibility: Yes 9, abstain 1 – general discussion
- f. Item 6: Rule 3.03: Yes 8, no 2 – general discussion
- g. Item 7: Rule 4.10 and Tournament rule 12: 9 yes, 1 no – general discussion
- h. Item 8: Rule 8.06 (a) and (b): 1 yes, 9 no – general discussion
- i. Item 9: Player Eligibility: 10 yes, 0 no – general discussion
- j. Item 10: Player Eligibility: 10 yes, 0 no – general discussion
- k. Item 11: Tournament Protest – Ineligible Player: 10 yes, 0 no – suggestion: allow #2 team to fill vacant slot so that the district has a representative in the tournament.
