Meeting Minutes: Greg G. motioned to approve as submitted, Brad A. seconded. Motion unanimously approved.

Old Business:

- ASAP: Extension given to March 21, 2018 to have submitted; initially D7 leagues were told March 13, 2018. District 7 will place a \$350 charge on plans not submitted by March 21, 2018. Little League has April 1 due date, however, Cari explained that this date does not allow for corrections etc. Please refer to the spreadsheet that was given at the meeting.
- 2. **Fees owed:** Cari addressed fees still owed to D7 from 2017 as well as monies owed to LL International again please refer to the spreadsheet given at the meeting.
- 3. **Background checks:** According to the latest Data Center info, only 7 leagues have run any background checks. Question/statement that means that there are leagues that haven't even ran background checks on board members, implies that player assessments have been done by people with no background checks. Background checks must be done. This information will be included on the next spreadsheet.

- 4. **Registration:** Leagues were asked who uses Blue Sombrero, another online registration or still does paper. This information will be included on the next spreadsheet (information used for registration data on DATA center).

New Business:

- **2. Player age form and fees:** Debbie passed around player age forms these need to be filled out and returned with a check this month. Update to numbers will be asked for in May 2018. Please do this as soon as possible.
- **3. Interleague forms/DATA Center:** All forms are now done electronically through the DATA center. Cari does still have to approve them. If the forms are not done, league(s) may not interleague. Debbie has email that helps explain how to do. Contact her if you would like help/email forwarded.
- **4. Combined team forms/DATA Center:** This form is on the DATA center as well. There is a deadline with this date and because this form is now online, the date will more than likely be enforced. April 10, 2018 deadline. Don't wait to fill it out and submit if there are combined teams.
- **5. Rules in effect for 2018:** Brandon explained/addressed rules that are in effect for the 2018 season and how they might affect interleague. 1) 15 run rule (4.10(e)) after explanation and discussion, Greg motioned to not apply the 15 run rule to interleague play and Tony seconded. Motion approved 9 yes, 1 no. Cari will contact Western Regional with a waiver to not apply this rule. (If WR does not approve rule will be followed.) 2) Players being married rule (8.06 (a)) information shared, no action taken. 3) Pitching rule (3.03) information shared, no action taken, and 4) No stealing signs rule Greg motioned, and Mike seconded to not implement the rule. Motion approved 10 yes, 1 no. Cari will contact Western Regional to not apply tis rule. (If WR does not approve rule be followed).)
- **6. Interleague teams:** General information March 20, 5 PM dates, contact information, blackout dates etc. **MUST** be given to appropriate scheduler. April 14, 2018 will be opening day for interleague games. Wednesday, April 4 by 5 PM, schedules will be sent out (sooner if they are available).
