Meeting Minutes: Motion made by Liz. and seconded by Jeff B. to approve the January 2019 minutes. Motion passed unanimously.

Old Business:

1. President check list

- **a. Financials:** Parrish has given D7 a copy of their taxes, taxes were due February 15, 2019. Please see that a copy of the paperwork sent in for your league is given to Cari.
- **b. ASAP:** It is **due March 1**st this allows for corrections or additional information to be submitted for approval by the April 1, 2019 deadline for Little League. It is submitted online with Little League. League's must have it submitted and approved in order to be considered a host for district or state tournaments.
 - i. Approved (as of 3.15.19): Cascade, Corvallis, East Lane, Keizer, Parrish, S. Salem, S. Valley, Sprague and West.
 - **ii. Not Approved (as of 3.15.19):** Eugene incomplete, Mid-Valley not started, Mt. Angel registration, Sheldon registration, Tri-Cities registration.

- c. **Backgrounds:** Cascade and Sheldon have run no checks so far for the upcoming season. Little League uses a formula of 6 checks per team chartered (official roster manager and 2 coaches, umpires, scorekeeper and team parent) as well as all board members are to have background checks completed. It was explained that based on that formula (using a league as an example and nothing more) Corvallis should be running approximately 252 checks for the upcoming season. Brief discussion on who needs a background check run. Lori H. said that she called Williamsport and asked that question; she was told that anyone having consistent contact with a player.
- **d. Monies owed and credited:** there is updated information on the check off chart.

- **1. Challengers:** Kids are signing up in Eugene and North Salem. Games will be held at Parrish on Saturdays at 10 AM. Information is on the D7 website. Volunteers are needed to help coach the teams as well (N. Salem has 2 volunteers and Eugene has 1).
- 2. Softball meeting: March 26, 2019 at Keizer Field House.
- **3. State Tournaments:** D7 is hosting State Major SB and State Sr. BB both tournaments will be at Keizer.
- **4. District Tournaments:** ASAP must be approved by April 1. Send an email to Cari expressing interest to host a district tournament and specifically which one(s). Fields will also be checked for compliance.
- **5. Player fees and form:** The form is available tonight. On the form, please be sure to list the number of teams per division and the breakdown of player ages in each division. For example if Tball is coed it can be listed under baseball unless the league specifically has a softball tball program, then the player ages and numbers would be listed under softball.
- **6. Combined Teams form:** That is done online though the Data Center. There is no longer paperwork filled out and sent in.
- 7. Interleague Teams:
 - **a. AA** Parrish 3 maybe 4 (not interleaguing), S. Salem 3, Keizer 5, W. Salem 8 (not interleaguing). Keizer will schedule.
 - **b. AAA** Keizer 3, Mid-Valley 2, Parrish 4 (not interleaguing), S. Salem 3, Sprague 4, W. Salem 6 (not interleaguing), Tri-Cities 1. Keizer will schedule. South leagues 9 total. Steve will schedule.
 - **c. Majors** Cascade 1, Eugene 1, S. Valley 1, East Lane 1, Sheldon 1, Keizer 1, Parrish 4 (not interleaguing), S. Salem 1, Sprague 5, W. Salem 4 (not interleaguing). Cascade is scheduling. Batting 9 at this level.
 - **d. 50/70:** Cascade 1, Corvallis 2, East Lane 1, Keizer 1, Sprague 1 (has 17 kids will combine with Cascade to fill their team), W. Salem 1. Keizer will schedule.
 - **e. Juniors:** Cascade 1, Keizer 1 (combining with West), Parrish 2, S. Salem 1, Sprague 1. Cascade is scheduling.

- 8. Interleague Rules: Interleague Softball Rules will be done at the Softball meeting March 26.
 - a. AA Rules Addition:
 - i. Once ball reaches infield grass, runner can not advance past currently occupied base.
 - **ii.** 5 Run 3 out per inning (see rule 8 in AAA for wording)
 - b. AAA Rules Addition:
 - i. Ten run rule (see rule 12 n aa for wording)
 - c. Major Rules Deletions:
 - i. Rule 6 Batting 9 at this level (no continuous)
 - **ii. (questions regarding)** Regulation 7 in Rule Book pg. 48: Major Division: there is no time limit on games unless necessary, based on field limitations. [see Reg. X(c)] Regulation X[c] reads: When league size and field availability require leagues to schedule more than one game on the same day or night and on the same field, the league may be permitted to impose time limits on games. However, games must meet requirements of Rule 4.10 or 4.11 to be official. (Rule 4.10 is the 6 inning regulation and 4.11 is the 4 inning regulation).
 - d. 50/70 Rules:
 - e. Junior Rules Deletions and Additions:
 - **i. #8:** No fifteen rule after four innings.
 - ii. #12: 15 year old player will be allowed to pitch (If 15 year old is on team(s), get waiver to Cari)

Motion made by Mike and seconded by Chris to accept BB Interleague Rules: 7 approve 3 oppose. Motion approved.

- **9. Keizer:** Pioneer monies Debbie said will try and take care of this coming week.
- **10.Tri-Cities Umpire Clinic:** This coming Saturday 3.16.19 at West Valley Community Campus. 9-12 is Umpires, lunch, and coach's clinic in the afternoon. All are welcome, lunch is on Tri-Cities.
- **11.Sprague Umpire Clinic:** March 23 at Crossler Middle School 9 AM.
