#### **Old Business:**

- 1. ASAP: The District is very close to 100%. Sarah will check on Mt. Angel's plan. They have a letter stating approval.
- 2. Concussion Training: Must be done prior to team practice. It is Oregon law make sure all coaches, managers and umpires have completed.
- 3. Background checks: Run on anyone that works with players or handles monies (as in fundraising chairperson). Sarah reminded presidents that the Umpires registered in the Umpire Registry does not t have a local league run a background check. Jalynn runs for the District. Reach out to her if need help or has a question.
- 4. Diamond Leader training reminder: Anyone manager/coach considering All Stars must have this training completed.
- 5. Advantage Mortgage Invitational Tournament (Mike Majors): Will be held Father's Day Weekend at the Volcano Stadium. Flyer attached to draft minutes as well as sent out last month.
- 6. Waivers: Due by June 1 meaning they must be approved by June 1. Please be sure and get them in to allow for approval.
- 7. Boundaries: there has been an issue with the Mt. Angel, Keizer, Parrish SB boundaries in the past, believe the issue has been corrected and addressed. Challengers is a soft boundary. Direct player/family to Jalynn. There are two divisions to Challengers. Games are tentatively set to happen on Saturdays beginning April 22 through June 17. Place to be determined. Leslie mentioned that working with Tri-Cities learned Lori has access to an indoor gym with a diamond and bases set in the floor in Grand Ronde. There is no charge for the facility for Sunday use.

### **New Business:**

- State Tournaments: A spreadsheet is attached to the draft minutes showing the dates and locations for 2023 State LL Tournaments. Little League wants 7 days between State and District to allow for fundraising, travel plans, and player rest. Greg A. State LL UIC, will gather names of umpires available for state tournaments, but scheduling crews will be done at the District Level for District Tournaments. Some tournaments are modified double elimination meaning no 'if' game. Double Elimination means a 'if' game.
- 2. District Tournaments: Hope to have tentative schedule out next week. Please realize that there will be some modification as leagues estimate teams and then there is what actually happens. Those changes impact length of tournament as well as the brackets.
- 3. Interleague teams: Leagues were asked how many teams at what level and a spreadsheet was created and will be emailed out along with forms that will create a contact list. Information needs to be entered by March 12 after which a schedule will be created and proofed. The final schedule will be released April 1, 2023
- 4. Interleague Rules: Sarah will send out and feedback given. It is important that all managers have a copy and follow the rules. Umpires will receive a set as well.
- 5. 15 year old pitch at Jr. level: It was motioned by Mike M. and seconded to allow 15 year olds to pitch at the junior level. Motion was approved unanimously.

John Foster: some leagues are not using dangling throat guards on catchers' helmets. This will be included in the Interleague rules but know that it is a LL rule already.
