I, the undersigned, understand that the Fallbrook Pop Warner Football League, Inc. (hereinafter referred to as FPW) is loaning "as is", one of each of the following items to the registered participant listed herein:

- Football Helmet
- Football Shoulder Pads
- Game Pants, Practice Jersey, & Practice Pants

herein referred to as equipment. I understand that FPW, its elected and appointed officials, volunteers, and others working on its behalf, make no warranty of condition or the proper fit of this equipment. I understand it is my responsibility and the responsibility of the player parent/guardian to inspect this equipment prior to each use. I further understand that I or my player/child are not to use the equipment if I discover any defect, damage or malfunction of the equipment or any part of the equipment. I agree to return the equipment to FPW with a written report of any known defects, malfunctions, damage, or concerns related to the safety of this equipment. I understand FPW makes no promises, guarantees, representations, or warranties, implied or otherwise, from the loan of this equipment as to the safe condition, functionality, or operability of the equipment, or of any of its parts, or of any work previously performed on the equipment, including recertification, repair, modification, and maintenance work. I understand that FPW assumes no liability for any loss, damage, or injury to any person or property that occur subsequent to the loan transaction, nor for liability of any other kind on matters related to or arising from the equipment I borrow from FPW. I agree to hold FPW, its elected and appointed officials, and volunteers harmless for any bodily injury or property damage sustained by me or others as a result of the use of this loaned athletic equipment. **I assume responsibility for the loss of this equipment and agree to reimburse FPW for the full cost to replace any equipment that is stolen, lost or damaged beyond reasonable repair.** I understand that I am not to loan this equipment to any other individual. I also agree to turn in all my child's cleaned equipment at the end of the season. Failure to comply will result in forfeiture of part or all of my equipment deposit.

You may provide the Equipment Deposit in one of two ways: 1.) Issue a Check to FPW in the amount of \$150.00 that will returned or destroyed upon the receipt of the equipment at the end of the current season. 2.) Fill out and sign the Credit or Debit card Authorization (Below) which will not be issued or charged to your card unless the equipment has not been returned in accordance with above stipulations.
