WAIVER/RELEASE FOR COMMUNICABLE DISEASES INCLUDING COVID-19

ASSUMPTION OF RISK / WAIVER OF LIABILITY / INDEMNIFICATION AGREEMENT

As consideration for being an Affiliate Member in Good Standing with California State Soccer Association-South (Cal South) and participating in athletic programming, sanctioned activities and events (collectively, "Sanctioned Activities") related to the California State Soccer Association-South (Cal South) the undersigned acknowledges, appreciates, and agrees that:

1. Providing participation opportunities in such Sanctioned Activities inherently includes possible exposure to and illness from infectious diseases, including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
2. THE AFFILIATE MEMBER KNOWINGLY AND FREELY ASSUMES ALL SUCH INHERENT RISKS, both known and unknown, EVEN IF ARISING FROM THE ACTIVE OR PASSIVE NEGLIGENCE OF others, and assumes full responsibility for participation; and,
3. To comply with the stated and customary terms and conditions to be an Affiliate Member in such Sanctioned Activities as regards to protection against infectious diseases. If, however, it observes any unusual or significant hazard during participation, it will cease participation and bring such to the attention of Cal South immediately; and,
4. On behalf of our organization, HEREBY RELEASE AND HOLD HARMLESS Cal South officers, directors, officials, agents, and/or employees, other participants, other Affiliate Members, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event, WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE ACTIVE OR PASSIVE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law. Further agrees to defend and indemnify California State Soccer Association-South (Cal South) for any and all claims, suits, allegations or actions brought against Cal South arising out of, relating to or based in any way out of such participation.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IF FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
