



MINUTES OF November 12, 2025, LTJBSA GENERAL MEETING

Virtual:

Review of Minutes: Meeting called to order by LTJBSA President, Paul Vichroski. A motion was made to accept the October 2025 meeting minutes.

*A motion was made to open the meeting minutes of October 2025 – unanimously approved

Treasurer's Report:

Dave S. gave the Treasurer's Report.

- **Motion:** A motion was made to accept the Treasurer's Report.
- **Financial Summary:** The league has money and plans to spend it on uniforms. A lot of money comes in during the winter, largely from registrations, and a lot goes out in the spring.
- **Registration Income:** New income is mainly from registrations, which are now over 100.

*A motion was made to accept the Treasurer's Report – unanimously approved.

Little League

Paul A. gave the report.

- **Fall Cleanup:** Travel coaches and parents completed the fall cleanup in a record-setting 90 minutes.
- **Registration Update (Current Numbers):**

- Registrations are tracking as expected.
- T-Ball has 82 registrants toward a goal of 96.
- **Budget and Cost per Player:**
 - The cost per player to put them on the field this year is **\$302**.
 - The effective cost per player to parents (after coupons) is about \$179.
 - The current fundraising gap is **\$54,000**, the most in years.

Fundraising Discussion

- **New Idea: Baseball/Softball Dedication Signs**
 - **Concept:** Customizable baseball-shaped signs to be displayed on field fences. **Andrea** mentioned they would have a softball version as well.
 - **Cost/Profit:** Parents would pay \$40 (or \$30-\$40). The league could make a profit of \$5, \$10, or \$15 per sign.
 - **Logistics:** The signs would have four grommets and be attached with zip ties. It would involve creating templates and a mail merge process.
 - **Concerns:** It was advised to check with the LTPD (Police Department) regarding the display of names, given past issues.
 - **Help Needed:** Andrea welcomes help with this initiative.
- **Other Ideas Discussed:**
 - **Corporate Match Plan:** An accountant confirmed this helps the league, provided donations are unrestricted.
 - **Online Store/White T-shirts:** Adding a white T-shirt to the online store was suggested.
 - **Amazon Affiliate:** Exploring an affiliate link to gain a small commission on gear like bats and was suggested.

*A motion was made to accept the Baseball Report – unanimously approved.

Travel:

- **Growth:** The program now has nine teams (six baseball, three softball).
- **Baseball Highlights (Fall 2025):** The 9U Thunder team went 9-1 and won their USABL league. The 15U Thunder team finished their run, with many moving to varsity and college play, demonstrating the program's long-term success.
- **Softball Highlights (Fall 2025):** The program shows progression, with the 9U Storm winning a game in their first tournament, and the 10U Storm winning two games against tough second-year teams.

*A motion was made to accept the Travel Report – unanimously approved
