President's Update

Executive Board Update

Several Executive Board (EB) members will not be returning for the upcoming term.

- Angelo Magliocco, Matt Del Rossi, and Kevin Chamberlain will be stepping down from the board.

District Update

- Connecticut District 2 has been dissolved by Little League International (LLI).
- At this time, the TLL Board does not know which district the league will be reassigned to.
- It is our understanding that Connecticut State Little League will determine the new district placement.
- The TLL Board has sent a letter to LLI and to Bristol requesting to be placed in **District 3** for several reasons. (The letter can be viewed on the TLL website.)

Grant / Turf Field Update

- The plan is for **Unity Field 4** to be fully turfed and completed by 2026.
- Construction may occur during the season, though exact timing is unknown.

- Construction fencing will surround the entire field during the project.
- The project timeline and groundbreaking date are managed by the **Town of Trumbull**, which is also funding and running the project.
- TLL will not provide financial backing for this project.
- Angelo Magliocco and Kevin Chamberlain have volunteered to serve as **Auxiliary Board Members** to assist with the project.

Projects and Successes – 2024–2025

The following initiatives were **organized and funded by TLL**, though the property itself is owned by the Town of Trumbull. TLL contributes significantly to the park's maintenance and upkeep.

Completed and Ongoing Projects:

- Unity 1 roof replaced
- Upgraded both concession stands to meet code requirements
- Installed new AEDs throughout the park
- Added new netting by Unity Fields 3, 4, and 5
- Implemented and coordinated a new key system throughout the park
- Fencing and gate improvements and repairs
- Hosted the District 2 Tournament and the 11U State Tournament
- Upgraded equipment throughout the year
- Held softball clinics at **Sacred Heart University**
- Held baseball clinics at **Technique Tigers**
- Included independent evaluators in All-Star selections
- Hired TLL alumni as umpires and announcers
- Provided paid training for umpires
- Added a **Fall season for the Challenger Division**
