- 1. <u>I, ACKNOWLEDGE</u>, agree and represent that I understand the nature of Rowing Activities, both on water and land based, and that I am qualified, in good health, and in proper physical condition to participate in such Activity. We understand that Crew Participants often practice off campus or away from the boat house on trails and roadsides contiguous to school property and on trails in park property or between the two locales.
- 2. FULLY UNDERSTAND that:
  - a. **ROWING ACTIVITIES INVOLVE RISKS AND DANGERS** of serious bodily injury, including permanent disability, paralysis and death "Risks");
  - b. These risks and dangers maybe caused by my own actions, or inactions, the actions of others participating in the activity, the condition in which the activity takes place, or the negligence of the releases names below;
  - c. There may be other risks and social and economic losses either, not known to me or not readily foreseeable at this time: and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITIES FOR LOSSES, COSTS, AND DAMAGES I incur as a result in my participation in the activity.
- 3. **AGREE AND WARRANT** that I will examine and inspect each activity in which I take part as a member of the Club and that, if I observe any condition which I consider to be unacceptably hazardous or dangerous, I will notify the proper authority in charge of the activity and refuse to take part in the activity until the condition has been corrected to my satisfaction.
- 4. <a href="HEREBY RELEASE">HEREBY RELEASE</a>, discharge, and covenant not to sue Colgan Crew Association, Inc., Prince William Crew Association, US Rowing, their administrators, directors, agents, officers, volunteers, and employees, other participating regatta organizers, any sponsors, advertisers, and if applicable, owners and lessors of premises, on which the activity takes place, (each considered one of the releases herein) from all liability, claims, demands, losses or damages on my account caused or allege to be caused in whole or in part by the negligence of the releases or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS each of the releases, from any litigation's expenses, attorney fees, loss, liability, damage, or cost which any may incur as a result of such claim.
