Dear Members

USRowing is on the move.

For the first time in 24 years, the world rowing championships returned to the United States and was an overwhelming success for the local organizing committee, the volunteers, fans and participants. FISA's President, Jean-Christophe Rolland, said that "The local organizing committee and USRowing established the gold standard for hosting future world championships."

The success of all of the U.S. national teams included multiple medal performances for the junior, under 23, senior and para-rowing teams. The foundation is being set not only for a successful campaign for the Tokyo Olympics in 2020, but also for Paris in 2024 and beyond.

For the third straight year, membership saw tremendous growth with increases in both new and returning members. Our team continues to work with organizing committees and to listen to our members as we introduce further enhancements throughout the year.

Participation in USRowing regional and national regattas continue to exceed expectations, and members can expect new initiatives that will continue to enhance both the competitive, as well as the "off the water" experience.

The success of the para-rowing team at the recent world championships is not only a reflection of these athletes and their coaches' commitment to performance but represents a growing constituency within our community. USRowing, along with our partners at the USOC, the Department of Veteran Affairs and member organizations, will continue to expand the support for these athletes and programs.

More international events will return to the United States. The 2018 World Rowing Masters Championships will be hosted in Sarasota, Fla., from September 26-28. USRowing also is in discussions with FISA to host additional events including junior, under 23 and senior world rowing championships. Our objective is to host each one of these events prior to the 2028 Olympic Games in Los Angeles.

This packet outlines the details of the 2018 USRowing Membership and Insurance Program. The comprehensive insurance services offered to our members by Roehrs and Company, Inc., and the Philadelphia Insurance Companies support regattas and provide coverage for running local club activities. This includes supplementary medical coverage for members, vehicle insurance for rental equipment, liability coverage for SafeSport-related issues and much more. The details are included inside.

The use of certified USRowing referees and the application of the Rules of Rowing are a fundamental part of organizing a successful and fair event and reduces the risk at these events. Please encourage your members to not only support these volunteers during events but to also consider becoming one. The view is incredible, and it is an important and valuable way to give back to the sport.

In 2018, members will see the launch of several new initiatives including educational services that focus on improving the experience of club leaders and members, athletes and coaches, as well as referees. This is your basic administrative fee at work, continuing to improve the support for both current and future rowers.

USRowing continues our work to move our sport toward the future and welcomes your continued support, as well as feedback. Our goal is to provide the relevant services and resources that promote and grow the sport. We welcome your input and can be contacted through our member services team.

Regatta Pass	\$175	Regatta Pass is a special rate providing organizational membership and insurance for a single regatta for up to 18 athletes. It strictly covers activities on regatta days only. This is not an annual membership.
Sub-Organization	\$400	Parent organization pays tier-level price, which covers parent organization and its subsidiaries. Each sub-club pays \$400 to USRowing and receives full liability coverage, has its own roster and the right to race under its chosen name.
Zero Members	\$625	Organization has zero members rowing under the registered name. Typically created for the purpose of fundraising, or hosting a registered regatta.



Tier 7 organizations must submit a valid certificate of insurance LISTING USROWING AS ADDITIONAL INSURED. If a certificate is not received within 14 days of your renewal, the membership will be suspended. While suspended, the club may not participate in any USRowingrelated activities. Organizational FAQs

Why does my program need an organizational membership with USRowing?

USRowing organizational membership is required in order to compete at the more than 200 USRowing sanctioned and owned regattas held nationwide every year. The membership provides your organization with access to our membership portal, which is the strongly recommended way to keep track of athlete compliance. Additional benefits, such as complimentary event promotion and access to coaching education, are listed on page 4.

Do all my members of an organization need to be members of USRowing and sign a waiver (online)?

Yes. Athletes or coaches without at least a current Basic Membership and signed waiver may not be eligible to receive insurance coverage in case of an incident. Tracking compliance online via your portal's active roster guarantees that USRowing and its insurance partner can quickly confirm the membership status of any participant filing an insurance claim.

My organization is holding a fundraiser that will include individuals that are not part of our club (such as National Learn to Row Day or a Learn to Row event). Are we still covered?

Yes. Miscellaneous special events and activities that involve groups other than your members (or USRowing members) are included automatically with your membership, subject to underwriting review. Please alert USRowing to any special events where you intend to host that require specific insurance coverage such as selling liquor, camps, etc. Paper waivers are accepted for participants in these types of events.

Our member organization also operates canoes, kayaks and stand-up paddle boards. Would these watercraft be covered under USRowing's insurance policy?

Yes, as long as these watercarft represent less than 30% of your fleet and you are not renting to the general public. More and more communities are expecting boathouses to be multi-purpose waterfront venues that serve a larger base. USRowing now offers multi-watersport coverage options for organizational members. Coverage includes canoes, kayaks and stand-up paddle boards for an additional fee of \$400 for clubs already enrolled in our insurance program. This does not cover exposure for dragonboats. You can sign up by logging in to the organizational membership portal at http://usrow.us/OrgMember.

What about other coverage that is not provided for my organization through the standard USRowing membership?

Starting this year, additional insurances – such as the Multi-Watersport Coverage listed above – can now be bought through the USRowing organizational membership portal at any time. Insurance options include crime insurance, hired & non-owned auto physical damage insurance and access to program-specific Directors & Officers and equipment insurance.

Will my member organization be covered if I race in an international event?

Your USRowing coverage is valid only in the United States, Canada and Puerto Rico. If you are attending an event outside these territories, you will need to contact Roehrs & Company about purchasing foreign liability coverage at (610) 363-7999.

What is SafeSport, and what does it mean for our organization?

USRowing requires that all member organizations join us in the SafeSport campaign to protect athletes across the country. All USRowing member organizations are required to have an athlete safety program. While the primary focus is to safeguard children, policies should extend to all age groups.

Is the sale of alcohol by our organization covered?

The sale of alcohol is not covered, but host liquor liability is included in the coverage and that includes fundraisers, banquets, etc., where you may serve alcohol as part of the function. If your organization is in the business of selling alcohol, you need to purchase specific coverage for this risk. Please call Roehrs & Co. at (610) 363-7999 for a Liquor Liability application.

Add the Regatta Package immediately when you join or renew with your Basic membership or add it at a later date. Note: Regatta Package Add-on for Basic Membership runs for the duration of your active Basic Membership. Adding it at a later date than initial renewal will not update your expiration date at that time.

Basic Add-on Coaches' Package \$25 total (Basic \$9.75 + Add-on \$15.25)

New for 2018! Adding the Coaches Package to your Basic Membership provides you with liability insurance and excess accident medical coverage (up to \$25,000). You also receive access to Experticity.com, where over 300 top outdoor and athletic brands sell popular gear at big discounts. Additionally, as a Basic Member with the Coaches' Package Add-on, you can row in USRowing-sanctioned regattas and attend USRowing coaching education events and the Annual Convention, but rowing in USRowing-owned regattas competition will require the separate Regatta Package Add-on or Championship Membership. Note: Coaches' Package Add-on for Basic membership runs for the duration of your active Basic Membership. Adding it at a later date than initial renewal will not update your expiration date at that time.

Basic Membership \$9.75 Admin Fee

Create a basic account and complete a waiver to become eligible to compete in USRowing registered (NOT hosted) regattas for a member organization. Basic members must complete this process prior to their first race (including indoor events).

International Membership \$75

Individuals who LIVE AND ROW outside the United States are eligible. Those rowing for a U.S. organization do not need an International Membership. Note: At USRowing-hosted events, international rowers need only basic memberships, as long as they belong to their native country's governing body of rowing.

Outreach Membership \$10

USRowing offers high school athletes, who demonstrate economic need, an opportunity to become Champ members at a reduced fee. Visit <u>http://usrow.us/outreach-app</u> for criteria and application.

USROWING ROSTER PORTAL



1) Administrators, coaches, and directors manage rosters and their account by visiting: <u>http://membership.usrowing.org</u>.

2) Login to your organizational account with RegattaCentral username and password or click "Join" to begin a new organization.



3) As an organizational manager, you can renew your membership, manage your account, manage your roster and also pay for athlete memberships in bulk.

4) Archive former crew members, delete non-members, add new athletes and merge duplicate accounts!

Archive, delete, merge and process memberships all in your roster.



FAQs:

Why do some athletes have duplicate records?

- 1. An athlete hasn't affiliated with the club and, therefore, is not on the roster. To remedy, she or he created a new account.
- 2. An athlete forgets his or her member number or password, has trouble logging in and creates a new account.

Where do I get my admin or club code?

These codes are emailed to you throughout the year. You also may find your club code in the "Settings" tab of your roster. Please contact <u>members@usrowing.org</u> or 1-800-314-4769 with any questions about your admin or club code. Note: Your organizational member number is not your Club Code.

An athlete says s/he completed the waiver but it does not appear on my roster. Why?

Athletes must affiliate with your organization in their account using your club code *(found in the "Settings" tab of your roster)*. An athlete may have signed the waiver, but if she or he has not affiliated, she or he will not be on the roster.



Requirements

- The host organization must be a current USRowing organizational member.
- All attending organizations must be current organizational members.
- All unaffiliated rowers must have a championship membership.
- All competitors must be a basic member and have a current signed waiver.
- Sanctioning fees must be paid in full, one month prior to the event.
- If the regatta is not using RegattaCentral's services, a list of attending crews must be submitted to USRowing when the first entry deadline passes and updated when late entries are completed.
- The Chief Referee must be fully licensed and have a current Championship Membership.
- Any exceptions or amendments to USRowing rules must be submitted to USRowing.

It is important to notify your insurance company of a claim (or potential claim) immediately after the incident occurs, so it information for any other involved parties. INSURANCE INFORMATION

2018 PROGRAM

USRowing offers the opportunity to add additional insurance coverage with your team's organizational membership and liability insurance. Premiums are for the duration of the annual membership.

Hired/Non-Owned Automobile Physical Damage insurance and the Multi-Watersport Coverage can be added by logging in to https://membership.usrowing.org. For all other options, please contact Roehrs & Co. at (610) 363-7999. Premiums cannot be pro-rated.

Hired/Non-Owned Automobile Physical Damage

This insurance offers physical damage coverage for any rented vehicles. The cost is \$275. The limit of the policy is \$75,000, the deductibles are \$100 per comprehensive and \$1,000 collision.

Multi-Watersport Coverage Option

Multi-watersport coverage option for organizational members includes canoes, kayaks and stand-up paddleboards. This policy does not offer coverage for dragonboats at this time. The cost is \$400 per calendar year.

Directors and Officers (D&O) Liability for Not-for-Profit Rowing Organizations

Directors and Officers Liability Insurance offers protection for lawsuits against the directors and officers of not-for-profit rowing organizations, as well as their volunteers, for actual or alleged wrongful acts and errors and omissions. The policy also provides coverage for suits brought against the entity itself. The available options do not provide coverage for lawsuits involving bodily injury or property damage. These types of claims can be covered under the General Liability Policy.

Please note: This coverage is written on a "claims made basis." All claims under this policy must be reported to the insurance company within the policy term. If your organization is a for-profit entity, you are not eligible for coverage under this program. For profit entities can contact Roehrs & Co. at (610) 363-7999

Option A: \$380 – Up to \$1,000,000 Directors & Officers Liability Option B: \$510 – Up to \$2,000,000 Directors & Officers Liability

Crime Insurance

This plan provides protection for rowing organizations against the financial loss caused by the dishonest disappearance of money, securities or negotiable instruments. This insurance plan includes coverage for loss by theft or forgery by an officer or volunteer.

Employee Theft Coverage: \$25,000 per loss On Premises Coverage: \$10,000 per loss Off Premises Coverage: \$10,000 per loss Depositor's Forgery: \$10,000 per loss

The deductible for this insurance is \$250. You will be required to provide a Prior Acts Exclusion form. The coverage is not active until the form, provided by Roehrs, is returned. The cost per calendar year is \$175.

NOTE: discounts are available for organizations simultaneously purchasing Directors & Officers Liability Insurance as well as Crime Insurance.
