AS SOON AS YOU WIN YOUR DISTRICT CHAMPIONSHIP:

1. Send a digital image of your team holding your District banner and roster with players, managers, coaches, league name and district number by email to Daniel Maine at CoeburnLL@yahoo.com as soon as possible. This picture and the roster will go in the program book.
2. Send email of all players, manager, coaches, league name and district number to Roger Morgan at roger-erica@charter.net as soon as possible. Please make sure spelling is correct. The roster will be listed on the back of the tournament shirt.
3. Send tee shirt order form to Roger Morgan at roger-erica@charter.net by July 8th.

Items to bring with you when checking in on July 15th:

1. Completed affidavit with all signatures and supporting documentation, including concussion training for manager and coach.
2. Two copies of medical releases for each player.
3. Little League Baseball, Incorporated 2021 Form Release and Waiver signed for each player, manager and coach.

A Manager, Coach and umpire meeting will follow be at 4 pm at the Inn at Wise.

1. Only rostered managers and coaches may attend.
2. Bring paper and pen for note taking
3. Bring rule book for reference
4. Questions and comments after meeting.

Streaming

Please have each individual affiliated with your team to complete the waiver/release form in this packet.

These are to be turned in at the managers coaches meeting. The purpose is to make everyone aware of live streaming of game and to get their permission.

Concussion Training

All managers and coaches will be required to complete a concussion training course. This course can be found by visiting www.nfhslearn.com. The course takes approximately 25 minutes to complete. A certificate showing that the course has been completed will need to be included for each manager and coach in the book.

Registration:

All teams, district administrators, umpires, and state officials should arrive at The Inn at Wise between noon-3:00pm, Thursday July 15th. Please come prepared to wear a mask if requested.

Please make arrangements with the tournament director if you are unable to meet the registration schedule.

Equipment

Each team is responsible for furnishing their own equipment for the tournament. There are several sporting goods stores in the area if anything needs to be purchased. Coeburn Little League may be able to provide equipment in emergency situations.

Practice Fields:

Practice fields and batting cages are available and can be scheduled thru Daniel Maine at 276-220-9894 or 276-395-2086.

Umpires:

Approved umpires will be used in all games.

Bob Shuler will be the umpire in chief for the games.

Team Guidelines

Teams are to arrive at the field 45 minutes before their game time and report immediately to the tournament director for a coin toss to determine home or visitor. The team traveling the greatest distance will call and the winner of the toss will choose home or visitor.

Each team will have 10 minutes of infield practice if time permits. This is the tournament director's decision. Only the manager, 2 coaches and a maximum of 16 players will be allowed on the field or in the dugout.

Pregame ceremony, players, managers, coaches and umpires will be announced at each game along with the Little League Pledge. The first game of the day will have the National Anthem will be played.

When your game is over, immediately go to the press box to sign your affidavit.
