# **Treasurer Report**

- Jim reviewed the 2014 financials and noted that the shed and bleachers had been incorrectly categorized as an expense earlier in the year but has now been reclassified as an asset. This change increased our net income by about \$4k for the year.
- League Toolbox is the online league management software/service that PBSA utilizes to manage registrations, schedules, teams, and communications. They charge 3.5% per credit card transaction, plus \$2 per registered player, plus an annual fee of \$300. We weighed the value of the service versus its costs and determined that we will continue to use them, although we should plan to look around for more cost effective solutions after the spring season.

## **Spring Registration**

- Registration will run from January 2 through March 6
- League fees remain the same as last year except that:
  - o The Jr. Baseball umpire fee is reduced to the same as Minor Baseball since we are going back to one umpire
  - Colt and Legion will have the same fee but those players making the Legion team will be responsible for paying any additional fees.
- The application process for managers will be online through the PBSA registration system.
- League reps are encouraged to make use of registration limits and a waiting list to help optimize the number of players per team in their respective division.
- We discussed various responsibilities that league reps have before, during and after the season.
