- Additional expenses for new Toros, baseball equipment, crushed red brick, top soil, sand, and uniforms.

- Foul line repairs are in progress.
- Turnout for Rookie Baseball work party was dismal.
 - o Poe will take the lead on improving turnout for future work parties by coordinating with league reps.
- Turf for batting cage near Field #8 to be completed by borough this week.

- Still looking to get a truck body for additional storage near Field #8 but there are flooding concerns.
- A sun screen for Field #3 is arriving in two weeks.
