- Review all by-law proposals
  - 1. Fundraising Policy for 12u Baseball Team Amendment pending legal review; will discuss at the November meeting
  - 2. Amendment to Article XI, Paragraph 2 of the PBSA Bylaws concerning the appointment of certain board positions. PASS – will move to vote by voting members
  - 3. Amendment to Article XIV, Section 1(a) of the PBSA Bylaws to include a Beginner Rookie division within our Baseball League structure. PASS – will move to vote by voting members

  - Lafferty any severe activity resulting in a suspension results in suspension until next board meeting; each involved individual can plead their case to the board
- Consideration that Baseball and Softball align wherever possible Will review at the November meeting
  - Director of Baseball/Softball to meet and review opportunity review draft, tryouts, callups
- Future Spot for dirt Near field 8 parking lot
  - o Boro will set and pave once we have bricks
  - o Will be 3 ft tall and 10 ft wide
