



Paso Robles Youth Football and Cheer (PRYFC) provides scholarships for registration fees for children, who without financial assistance would be unable to participate in PRYFC programs. PRYFC is a non-profit organization with limited funding available for scholarships. No guarantee of assistance is implied by this application. If the number of scholarship applications submitted and approved exceeds the amount available, the scholarships will be awarded by a lottery system. **PRYFC does not discriminate on the basis of race, color, national origin, sex or disability in its program.**

Requirements for eligibility:

- Athletes must be of eligible age to participate in a PRYFC program
- **Parents/Guardians agree to volunteer 8 hours per scholarship recipient**
- **Commitment to attend all scheduled practices and games**
- Families may be called upon to volunteer for fundraisers offered by the program

Please provide all information required to help PRYFC determine qualifications.

Scholarship consideration will be given to families that meet the following criteria:

- Receive assistance from programs such as: Food Stamps, Medicaid, SSI, Foster Care, WIC, etc. and can provide written documentation of participation in these programs. Must fall below the following household income thresholds:

- Provide a written statement of immediate financial hardship explaining the current situations. PRYFC recognizes that a family may not be receiving formal assistance from the programs mentioned above, yet financial assistance may still be needed to participate. In these instances, PRYFC will consider the financial hardship statement to determine scholarship eligibility. Please provide any supporting documentation that may support the facts of your financial hardship statement.

The amount of the scholarship awarded (if any) may be a partial or full scholarship depending on the number of applicants, and the amount of scholarship funds available.

The parent, guardian or head of household will be notified in either case of a scholarship being awarded or not.

Approval of a registration scholarship does not register the participant in the activity. Athletes must still register for the sport the scholarship was awarded.

Financial assistance applications will be held in confidence between the parent/guardian and the scholarship committee.

_____ 6. I understand that if a scholarship is awarded to my child or multiple children, I am required to volunteer 8 hours per scholarship recipient. Failure to satisfy this condition will disqualify me, my child(ren), and my immediate family from being considered for another scholarship for 12 months.

_____ 7. I understand it is my responsibility to ensure my child(ren) attend all schedules practices and games.

_____ 8. This application is considered private and will not be shared with anyone other than the scholarship board.

_____ 9. I understand I must make a \$50 down payment. If this amount is a hardship please notify the league.
