CASA Monthly Board Meeting Minutes

1. Call to Order

3. Committee Reports

- a. Coaching:
 - C Derry suggested using buyout monies for more coaching education, particularly to send a coaching individual to a soccer/coaching conference.
 - ii. Issue of one U8 coach that missed approximately the last three games of season. E Sayer, J Nickelson and C Derry will make further inquiries.

b. Concessions

 Donations to High School soccer teams from the concessions profits: E Sayer has suggested a donation of \$2,000 (estimated) to high school teams from Concessions profits. C Derry motioned to approve; S Bietz

- ii. J Helmbrecht asked for clarification if 25% or a certain dollar amount was done in the past. Also voiced concerns that this year's seniors should benefit from the donation, instead of monies being held for next season/year.
