Tim Shirey will get more information about selling Joe Corbi Pizza  
Members decided against doing a raffle on opening day and selling Boscov's discount tickets  
Discussed the Golf Outing and the amount of work involved BYB board has decided to cancel due to lack of volunteers/sponsors

**TEXAS FIELD:** BYB president Jason Perrott and secretary Lisa Kraljevich along with BYB members, Star Stevens, Melanie Thompson, Ed Miller and Tim Shirey attended Birdsboro Parks and Recreation board meeting on Wednesday March 16<sup>th</sup> to discuss concerns about the usage of Texas Field and if we would have to share the field with Douglassville Baseball (DBYS)

After much debate Birdsboro Parks and Rec Board members decided to grant BYB sole usage of Texas Field for the 2011 season . BYB would not

need to share Texas Field with DBYS Baseball

Parks and Rec Board member Mr. Tucci stated that we would need to start negotiating with the Parks and Rec Board in July 2011 for the 2012 season

**OPENING WEEKEND:** Opening weekend is scheduled for Friday April 29 and Saturday April 30

**TOURNAMENT TEAMS:** Try-outs were held Saturday March 26 for the 7-8 and 11-12 teams

The 9-10 year old team has already been formed, try-outs were held in February.

Discussed charging parent's \$30 fee for the tournament teams to help cover the cost of entering tournaments.

Also discussed having tournament teams participate in a fundraiser to help defer the costs of entering tournaments

Looking to close out 13-15 year old registration by April 15 and get uniform order for 13-15 year old to Starr Stevens by April 22

**SNACK BAR:** BYS will purchase Sam's Club Membership to do shopping for snack bar  
Melissa will price items and determine snack bar prices for this year  
Kelly Biagianti will be minors snack bar coordinator  
Amy Lessig will be majors snack bar coordinator  
Lisa will send an e-mail looking for a rookie snack bar coordinator  
Lisa and Kelly will clean-up and inventory snack bar the week before snack bar is scheduled to be opened  
Orders for items needed are to be placed by Thursday so that items can be picked up on Friday at Sam's Club  
Looking into possibly having high school students volunteer to work snack bar  
Absolutely no children under the age of 12 will be allowed inside snack bar
