2. Each Monday beginning after the first Concession Stand operation, you will provide to Ingram Little League's Treasurer a weekly Net Profit Statement for the Concession Stand.
3. Each Monday beginning after the first Concession Stand operation, by the end of business Monday of each week, you will pay to Ingram Little League's Treasurer the agreed upon League's percentage of the Net Profits.
